1. You will receive a zoom meeting invitation from the host. It will be scheduled the same time as your meeting time.
2. You can receive the invitation in an email or in a calendar invite.
3. Here is what a zoom meeting invitation will look like:

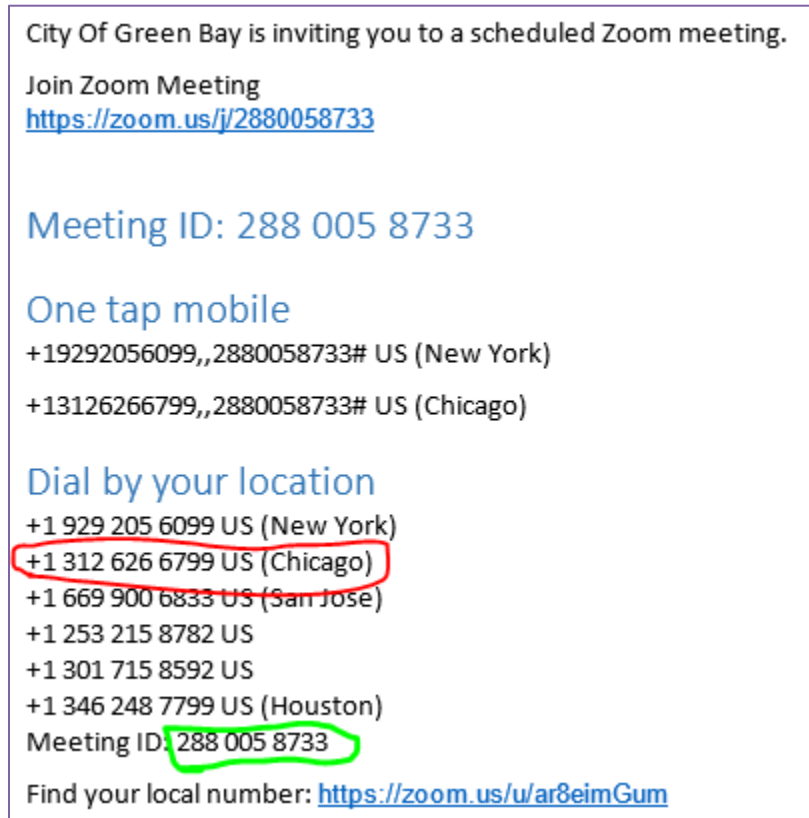

4. Wisconsin Open Meetings Law still applies
 - a. Persons interested in speaking to an item must give their name and address
 - b. Committee/Commission/Board members will still follow *Roberts Rules of Order*
5. Once you are in the meeting please mute yourselves. City recommended practice is to:
 - a. Allow a waiting room—this means the host will admit you to the meeting
 - b. Mute upon entry—this means that your phone or computer will be muted when you are allowed into the meeting. You can still hear the meeting's proceedings.
6. Waiting room
 - a. Committee members will remain in the meeting until it's concluded
 - b. Persons on the agenda will be admitted to the meeting, and then once the item is concluded, the host will permanently mute you from the meeting (you can still hear the meeting). There is a process the committee will undertake called "opening the floor." Persons interested in listening to the meeting can go to www.youtube.com/CityofGreenBay
 - c. The host of the meeting may ask you to identify yourselves, if you're calling in with a phone.
7. Using Zoom with a tablet or computer

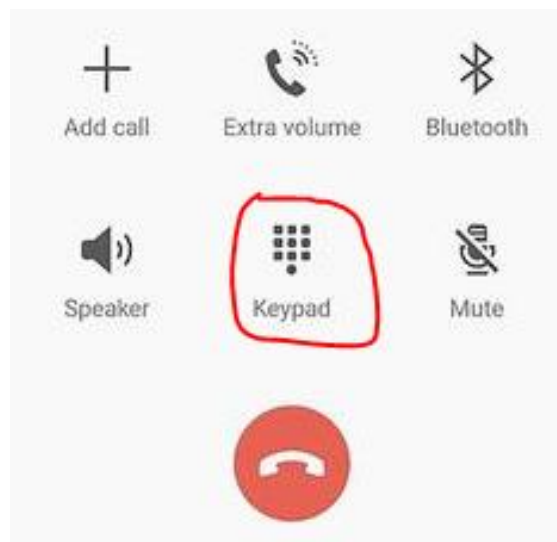
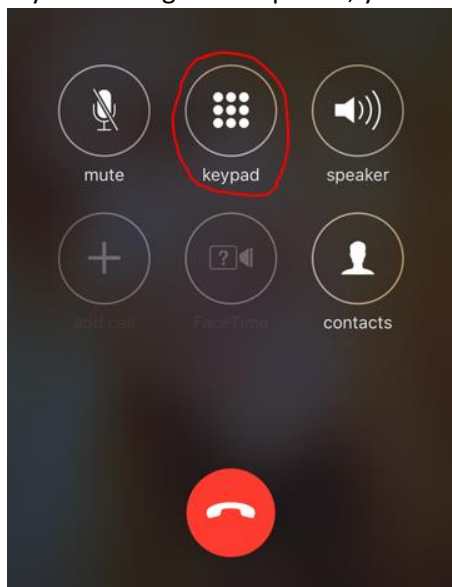
- a. Tablet—you will be asked to sign in. Download the app either with the Apple Store or the Play Store
 - b. Computer—you will be asked to sign in. You may download the app or click on the link to open Zoom in your browser.
- 8. Registering
 - a. The host may ask you to register for the meeting. A registration link will be sent to you along with the invite. You'll receive another email confirming that you're registered for the meeting.
 - b. If you're using a phone, your registration will still be tied to an email.
- 9. Raising your hand
 - a. Committee members—you can either use CivicClerk and request to speak or you can "raise your hand" in the zoom meeting (you'd need to use a computer or tablet) to let the host know you'd like to speak. You can also un-mute yourselves and start speaking.
 - b. Persons on the agenda—you can "raise your hand" but you'd need to use a computer. You will be allowed to speak, per Wisconsin Open Meetings Rules, once the committee has "opened the floor for interested parties to speak." Once the committee is finished with your agenda item, the host will mute you permanently, unless the committee opens the floor again. Once muted, you can still hear the meeting.
- 10. Staffing
 - a. During a committee meeting, there will be at least one staff member in one of the recording rooms (council chamber, 207, 310, 604).
 - b. The staff members will be the hosts of the meeting and will manage callers with muting and admitting.
- 11. What devices should I use?
 - a. Smart phone (please see more detailed instructions on pages 3 and 4 for telephones)
 - b. Land line
 - c. Tablet—well in advance of the meeting, please download the Zoom Meeting app before you join a meeting by using either the Apple Store or the Play Store. You will be asked to input your name, thus identifying you for the meeting. You'll also be asked to verify your email.
 - d. Computer—well in advance of the meeting, please download the Zoom Meeting app, but you can also click on a link to open the Zoom Meeting in your browser. You will be asked to input your name, thus identifying you for the meeting.
 - e. For tablet and computer users—if you download the app you will be asked to verify your email.
- 12. Zoom etiquette
 - a. Muting yourselves when you're not talking will prevent your background noise from interfering with others' ability to listen to and participate in the meeting.
 - b. If you're using a telephone, please identify yourself with your phone number and name before you speak. Zoom meeting hosts can see only your telephone number.
- 13. Closed session
 - a. During this time when we are using virtual meetings, we may use YouTube (www.youtube.com/CityOfGreenBay) for the public. We can't turn-off the You Tube recording, so all closed session items will be discussed in an adjoining room, where there is no video equipment.
 - b. Persons listening in will hear the committee take a vote to go into closed session and will then hear no voices until the committee returns.

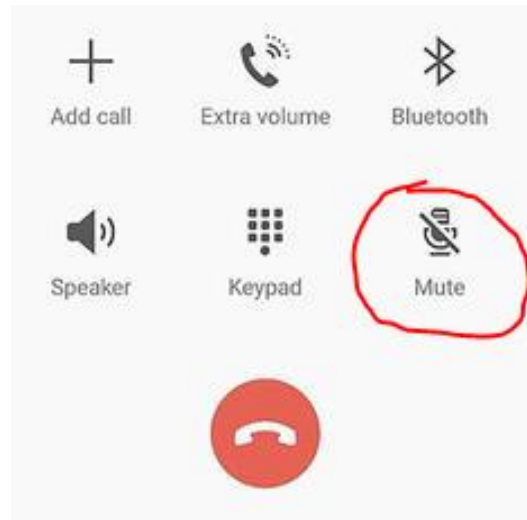
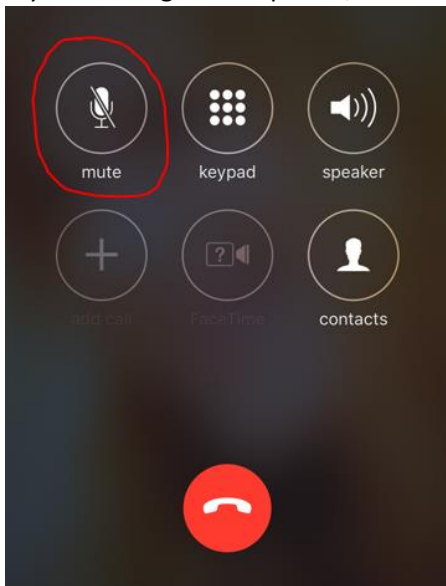


2. Use your phone to dial the phone number listed in Chicago location (red circle in example image above)

VERBATIM MINUTES

- **Okay, we'll get started with the sex offender residency board meeting. We'll first take roll call.**
- **All right, I'll capture it.**
- **Okay, I need a motion to approve the agenda.**
- **I'll make that motion.**

- And I'll second.
- All in favor.
- Aye.
- Vote?
- Looking like everyone's a yes.
- Okay. If we can get an approval of the minutes from the February 19th meeting.
- I'll make that motion.
- And I'll second.
- All in favor.
- I.
- I.
- I'll write it down.
- Okay, the first person we will hear is Joshua Lemerond. We need to call.
- [Elizabeth] This is Elizabeth Statton, New Lisbon Correctional.
- Hi, this is Heidi Michel with the Green Bay Sex Offender Residency Board. We're here to talk to a Joshua Lemerond.
- [Elizabeth] Yeah, I have him in my office and I'll put on the speaker.
- Okay, thank you.
- [Elizabeth] All right, you're on speaker.
- Okay, Mr. Lemerond, we're here to hear your appeal to move to 201 Bluth Street, Apartment C, is that correct?
- [Joshua] Yep.
- Okay, have you ever appeared before us?
- [Joshua] No.
- Okay, so we're gonna ask you a couple of questions while you are in a room full of individuals right now. The first thing we'd like you to do is talk about your crime and

what you are convicted of. We ask that you do not refer to the individuals by their relationship or by their name. So if you'd like to tell us what happened.

- [Joshua] She gets us on Craigslist and looking for somebody and I was heavy intoxicated and I know I wasn't right or nothing. I guess an underage girl responded and I was talking to her for a couple days and might as well meet up, and next thing put in handcuffs and put in jail.

- Did you know she was underage?

- [Joshua] Oh yeah.

- And what was your intent when you went to meet up with her?

- [Joshua] To have sex.

- And how old were you?

- [Joshua] 25.

- And she was how old?

- [Joshua] 16.

- I think that's the only question we ever have.

- When were you convicted of that?

- [Joshua] I can't recall.

- [Elizabeth] I could look it up if that would be helpful.

- Typically we have that information but I'm having a difficult time finding it.

- [Elizabeth] Sure, I can tell you. He was convicted on that case on 8/06/15.

- And when are you scheduled to be released from prison?

- [Joshua] April 7th, 2020.

- Do you guys have questions about his crime?

- No, no, it's in here.

- And that crime happened in Shawano County, right?

- [Joshua] That's correct.

- Okay. Why are you looking at moving to Green Bay?
- [Joshua] Because that's where all my family lives and I have a job there, that's why I personally lived my life, in Green Bay.
- What is your job?
- [Joshua] Flooring.
- Flooring.
- Oh, flooring, flooring.
- So, if you knew she was underage, why did you pursue it?
- [Joshua] I was heavy under the influence of meth and Adderall, and I really don't know why. I really wasn't sleeping at all, I actually don't know. I know it was wrong and everything, sorry for it. I honestly don't know.
- If you wanna, I wanna ask about treatment. I see what it says here, but if you wanna give him the option.
- Yeah, so, we'd like to discuss your treatment and you have the opportunity to do that in closed session or remain in open session. What would you like to do?
- [Joshua] Whatever would be more helpful for today.
- It's your choice, it's your choice. We need to know what you would prefer ope, you know. When we say open, we have other folks in here who are waiting. Closed, we would ask them to clear the room.
- [Joshua] I'm willing to do the open.
- Okay. So then we'll talk about your treatment.
- The paperwork I've got in front of me shows that you have not undergone any treatment while you were in prison, is that correct or have you had any treatment, whether for sex offender, alcohol, or drugs?
- [Joshua] I ain't doing treatment.
- Why not?
- [Joshua] Well I just think I can, I'd rather do it out there.
- Was it offered to you at all?

- [Joshua] Yeah. Just sex offender treatment was.
- Right.
- And what about the LDA treatment, 'cause you mentioned that you committed your offense, you were drunk and you were high at the time.
- [Joshua] Just high, on meth and on Adderall, and marijuana.
- Okay. So, have you done anything about, about dealing with that?
- [Joshua] Yeah, I'm gonna do stuff, like all classes I need to do out there, if need be.
- Okay.
- Usually we like to see that prior to okaying you to move to a residence.
- Yeah.
- So, if you took some of that, that would be behind you. Seeing help.
- [Alisa] I'm not sure, do you want me to interject if I have more information?
- Can she?
- I just need to capture her name.
- We just need your name for the record.
- [Alisa] Sure, my name's Alisa, I'm a social worker. He's a low-risk inmate, and low-risk inmates can do, it's very informal programming. So, he wouldn't be able to, in the DOC have a go to group or something. He has to just do these worksheets. Like, it's a self-help thing. It's pretty informal since he's a low-risk, programs would've been low. Programs like, that's why he had to do the ALDA.
- Okay.
- Okay, thank you.
- Does anyone have any other questions, or anything they'd like to talk about?
- I don't have any questions.
- No, I don't have anything else, thank you though.
- All right, are you from the city?
- Yes, I'm with the police department, yes.

- What he told us, is that accurate?
- There was one inconsistency between what he's saying and the police report that I think should be noted.
- And what is that?
- He was mentioning that the person who he believed he was meeting, which was actually the undercover investigator, he said that she was 16 years old there's numerous times during that chat that this undercover investigator said that they were 15 years old, so it makes quite a difference in charging.
- Sure, okay, thank you. Would anybody like to make a motion?
- We do have someone who wanted to speak.
- Oh, I'm sorry. There's somebody here.
- That's okay.
- Who wants to speak on his behalf. Come on up.
- [Jim] I'm Jim Classen, I'm Joshua's grandfather.
- Okay, if you can just have a seat.
- [Jim] I'm Jim Classen, I'm Joshua's grandfather.
- Okay.
- [Jim] Yeah, we've been goin' out periodically throughout the years that he's been in there, your honor. We really notice a difference in his mannerisms, from being on the drugs before, and now where he's calm and he's gotten into, he's part native, so he's gotten into religion with the native organization out there. So he's totally a different person than he was five years ago. And he's a hard worker. When he was working, doing flooring, reports said, "Good job," and he made it to work. So, I think he's really turned his life around.
- Okay.
- [Jim] That's it.
- So he'll be working for you?
- He'll be working for her husband.
- [Tammy] Yeah. He was always there--

- You need to just state your name for the case.

- Oh, I'm Tammy Bacon, I'm Josh's mother. I live with, he would living with us. Very hard worker, always very family-oriented. He's very good with everybody. He doesn't really know anybody in Shawano. The crime happened in Shawano, it was on Craigslist, and if he had to be on probation in Shawano, I don't know if he would have to live there, but I would just really like him to live with us if he could.

- I can.

- He has job, he would have his own vehicle. And he would be able to go to his meetings whenever he needed to, and there'd be no problem with his work. But yeah, with the religion that he's been going to, I feel like he is a totally different person. And we've had many talks about the drugs and how it was very scary. I'm actually kind of grateful that he was caught because I feel like if he wasn't, he probably would be dead. I mean, because of the drugs.

- Okay, thank you. Is there anyone else? Okay. Is there anyone who would like to make a motion?

- I'll make a motion to approve Josh Lemerond to 201 Booth Street, Apartment C, address specific. I would like to see him back here in, say 60 days, to see how he's doing with any treatment that he's gotten involved with.

- Is there a second?

- I would second that on the condition that when he is out that he immediately gets into treatment programs, and have proof of that, bring back proof of that when he comes back. We'll see how he's doing.

- Okay.

- So just that I've got the motion correct, to approve him for 60 days, to return with proof of enrollment in a treatment program?

- Yes.

- Okay.

- Yeah.

- Okay, we'll take a vote.

- Motion passes, two to one with one abstention.

- Okay. Mr. Lemerond, you've been approved to move to Booth Street, you'll need to come back in 60 days, and you'll need to have documentation that you're in treatment.

- [Joshua] All right.
- All right, thank you.
- [Joshua] Thank you.
- Thank you.
- All right, bye. Okay, next on the agenda is Sandra Plansky. You are looking to reside at 627 Harton Street, is that correct?
- Yes, I've been there a little over six years, I'm here to make sure I become compliant with city regulations.
- Why, why now?
- Listen to me I believe that I've changed.
- I'm sorry, that was my fault. I accept full responsibility for my actions.
- And how did you become aware that you weren't compliant?
- Because I'm on probation right now.
- And you weren't previous?
- No, I've been off probation since '99, maybe 2000.
- Okay. So this the first time you've come before us.
- Correct.
- As we indicated earlier, we'll ask you to tell us what you were charged with. Again, don't state the relationship or the names of the victims, and how it came to light.
- It was 1992, first degree sexual assault.
- What happened, what did you do?
- Sex with minors.
- We need, like more specifics, please.
- Like how specific do you want me to be?
- Just not names, yeah, not relationship.
- They were underaged children.

- Okay, and what did you do?

- This is gonna be hard for me to describe because I honestly do not remember. I remember what I was accused of, but the actual acts, I have no memory of whatsoever.

- Why is that?

- I, you know, I've struggled for a lot of years to figure this out and I honestly can't. I don't know if my mind just, because of the horror of it, blocked it all out. I don't know.

- How do you know there was horror in it, if--

- What I've read on the paper horrified me. It just, it's not something I'd see myself doing ever. I don't know if that's what caused me to block it, and I've tried, I've gone to treatment after treatment while I was incarcerated, afterwards while I was on probation.

- How old were you when this occurred?

- Mid-30s.

- And how old were your victims?

- Five and 10.

- Did you complete the application yourself?

- Yes.

- So, if you don't remember what happened, how could you say that you know how they would feel?

- Because if you read a book and you read something that horrifies you, or you read an article in the paper that's just, that's hard fact. I can feel when I'm reading a book with something, somebody's going through, and by the description of it, I can understand how they feel, and get a good idea of what they're going through.

- So, did you plead guilty, did you no contest, what was your plea?

- You know, it's been so long, I honestly don't remember, may have been no contest, not guilty.

- Do you remember how it came to light?

- I was called to the police department and then they read me my rights and they told me what happened.

- And do you remember what you told them?

- I told them I honestly had no idea what they were talking about.
- And, how much time did you get for that?
- 10 years, and I did a little over 5 1/2.
- And the rest was on probation?
- Yes.
- So when did you get out of prison?
- December of 1997.
- And then where did you move to after that?
- I went to a halfway house in Shawano.
- And how long did you stay there?
- Several months, and then I moved to the Wisconsin house and I lived and worked there.
- And then when did you move to Green Bay?
- I think 2003 I'm not sure. I'd have to find my old lease to know for sure.
- And then, in May of 2019, you failed to register as a sex offender, is that correct?
- Correct, I sent in my paperwork three separate times, and there was a disconnect somewhere.
- You know we have the criminal complaint, officer do you have anything different?
- Repeated acts of sexual assault on minors, sexual intercourse, several times a week this went on. Ages were correct that she described.
- If I may ask a question, is there anything in the reports that state that the appellant here does not remember what happened?
- I do not see that in the full report.
- Is there an interview with the appellant?
- Did you see the criminal complaint?

- Oh, okay.
- I do not see that in the criminal complaint.
- Okay, thank you.
- But were you saying that at the time of the arrest you didn't remember what had happened? Or are you saying you don't remember now? Or is it both?
- Both. I have no memory of any of it.
- So at the time of your arrest, when they came to handcuff you, were there children in the home?
- No, they were in foster care at the time. Their father and I were divorced, and I had been married, and I was about to get custody, the kids were about to move back in with me and all this came to light. And this was several years after the fact so, and I had been away from home, I'd went to visit my brother in Texas, sorry, in California, I was gone for, I I days with my ex on a trip to Florida. There was numerous opportunities for them to speak out. I found it highly suspicious that all of a sudden the kids were gonna come back to live with me and this comes out. And I can't say with 100% certainty, but I have a sneaky suspicion, because of the way my ex is, he had something to do with this. And I spoke with another lawyer, unfortunately it was too late, and he looked at the charges and he said he could've gotten 'em dismissed. He knew they were bogus.
- Okay there's no evidence to prove that, and we can only go with the fact that you were convicted.
- Right.
- No, I understand.
- So we cant go into what could've, should've, would've happened.
- No, I understand, I just want you to know--
- That's irrelevant to us right now.
- Okay, I'm sorry.
- Is there a relationship at all with these children, any more, or since then?
- We were working towards a relationship. I have four grandchildren. I did see my grandchildren, with their parents' permission. And then Kyle called and said that I was on probation--
- Okay, no names.

- And they told me they did not wanna see me. No contact, and I respect that.
- Okay. Anything further about her charges, or do you wanna go on to treatment?
- Treatment.
- Yeah. Would you like to discuss your treatment in open or closed session?
- Open is fine.
- Okay It looks like you did some kind of treatment while you were at Ellsworth, is that correct?
- While I was at Taycheedah and at Ellsworth, and then when I moved to Shawnao, I was in group there also.
- And what kind of group did you do?
- It was just at the probation office.
- And what type of treatment, did you do?
- Oh, sorry, sex offenders treatment, so I've been in three different treatment groups.
- Had you provided any documentation of that?
- My house was flooded out last year so a lot of my paperwork was destroyed in that flood I would love to provide you.
- Can you tell us like, what you did during sex offender treatment?
- We discussed what we had done, and what we need to move forward to avoid re-offending, change our thought processes.
- And how did you participate in class if you didn't know what you did?
- I would discuss if this situation came up or if that situation came up, what I'd do to avoid re-offending.
- Did you have any additional counseling or treatment during that time for drugs or alcohol?
- Drugs or alcohol were never involved.
- Okay.
- I have seizures so, I don't wanna lose control with drugs or alcohol.

- So what brought you to Brown County after being released?
- I have family down here, and the job market in Shawnao is not the greatest.
- Are you currently employed?
- Yes, I am. Been at my job over three years now.
- Okay, what do you do?
- I work at All-City Communications, it's a dispatch center.
- Anybody have any further questions? Would anybody like to make a motion?
- I just have one more question, I'm sorry.
- Sure.
- You said six years you've been here, in Green Bay?
- I've been down here since 2003. I moved into my house a little over six years ago.
- Oh, okay, that's where we're getting six.
- Is there a motion?
- It's hard to decide without any proof of anything, of treatment or anything like that.
- Mm-hmm.
- You know it--
- I can go through what I have and come back in a month if you'd like. I mean, I'm happy to do that.
- So you do have some?
- Well I would like to see if it was not destroyed in the flood, I cannot guarantee it wasn't.
- Can you get ahold of where you were? I mean, you know--
- 1992, my records are not even, 'cause Kyle checked but he cannot find anything.
- You were told to bring any and all documentation you had, right? In order to come before the board, regarding treatment and whatnot, right?
- Right, and to my knowledge it was destroyed in the flood.

- When did--
- I will look.
- When was the flood, when did that occur?
- Last March, that East River flood. I had over a foot of water in my house.
- Okay, so you didn't look for the paperwork?
- No, I will, my garage is still--
- I understand, I understand, but did you look for it?
- No.
- Well, I think she's asking 'cause it asks you that on the forms--
- Right, and I--
- And it's pretty important to your case.
- From what I remember, looking through what I have in my garage it was destroyed. But I will certainly be happy to take another look. I don't have a way to get it from anybody at this point because Kyle checked--
- Who's Kyle?
- I'm sorry, my agent, and he looked to see if there was anything in the system and he said "No."
- But you have not looked on your own, correct?
- Correct. Like I said, I will be more than happy to take another look and come back in a month if you'd like me to. It's not a problem.
- I'll make a motion to approve for 30 days of residency, 627 Harton Street, address specific. In 30 days we would wanna see you back with whatever paperwork you can find and documentation from your probation officer, is it Kyle Robowski?
- Yes.
- That he was unable to find anything to verify previous treatment.
- Okay, that's fine.
- Is there a second?

- I'll second that.
- Okay, take a vote.
- Just hang in there.
- Usually I get that one. I'll say yeah, that sounded like an angel.
- Do you want me to voice one?
- Yes.
- Motion fails, two to two.
- I can tell you what my concern is. I'm very concerned by the fact that you didn't come in with any paperwork to substantiate what you said about prior treatment, you didn't even look for it. Two, your denial of knowing what happened, completely denying, because in order to plead guilty, or no contest, or anything, you have to know what you did, the facts of what happened. Any public defender or defense attorney will not let you plead guilty or go to trial if you have no memory of what happened. Okay, I'm not gonna stop there for discussion, I'm just telling you my reasoning. Secondly, we, in not knowing, there's no paperwork, nothing as to how long you've been in the area, we know nothing, other than what you wrote down. And given the nature of the offenses and the seriousness of the offenses, I'm not comfortable voting to have you stay.
- That's kinda how I am. Typically, when it happened in Marinade, I don't typically approve people if they're from out of county because we have a room full of people who are from our county that are waiting to obtain residency here. I understand you've lived here for six years, but that's where I'm at. So, and I do have a real hard time that you can't remember anything of the offense at all. I understand it was quite a few years ago, but I think something that traumatic and serious, you would remember something.
- Believe me, I've searched my mind numerous times. I tried pretty much everything I could think of--
- Mm.
- That was a group standard.
- I feel the same too, actually, as you two but I did vote yes because she has been here for six years but--
- I've actually been in Green Bay since 2003.
- But yeah, I have concerns, for the same reason.
- Like they said, I will definitely look for my paperwork. Yeah, If I can get something from Kyle then.

- So, I'd like to make a motion to deny at this time.
- I'll second the motion. We'll vote again.
- So at this vote, a yes is supporting denial. Motion fails two to two.
- Failed then.
- She needs to have a majority in order to be approved. So, we don't have a majority vote. So, as of right now, she's denied.
- So I'm assuming you're probably in some kind of a lease, and you won't be able to stay there anymore.
- Do you have any suggestions as where I can go?
- I don't, I'm sorry.
- So you're kicking me out of Green Bay, basically?
- Well, out of that address, yes, we are. And then the police department will follow up with it that you are no longer residing there, otherwise you will be fined.
- And so I want a lawyer. Thank you.
- Thank you. Next on the agenda is Dillon Wendricks. So, Mr. Wendricks, you are looking at moving to 428 South Maple Street, is that correct?
- Yes.
- And this is your first time coming before us?
- Yes.
- So, as you heard, we'll ask you to tell us what happened, and again, don't refer to the victims by name or relationship.
- Okay
- Okay.
- Start?
- Yeah.
- Okay, when I was nine, I was introduced to pornography on the internet. Very soon after that I began compulsively and obsessively watching excess pornography for many years. It devolved I guess, or escalated into child pornography because, after so many

years of watching regular porn, it got stale. I got into child pornography in, 2016 I think I had downloaded some pictures. Well to find it, I never found it on the internet. I found it in an app, chat room type. So I downloaded a bunch of chat room apps. And I started posting like seeing what else is out there you know, I thought all apps are same, they related to everybody who's trading porn. I ended up posting a couple pictures of child pornography on Instagram. Instagram, notified these services and they traced my IP or internet I don't know where they trace the internet to the house. The victims were from 10 to 16 years old.

- They were what?

- 10 to 16 years old in the videos.

- How did you get introduced to it at such a young age?

- It was at sleep over with couple of friends who were sleeping there and one of them turned it on.

- And you were how old when, you got caught for doing this?

- I downloaded the pictures and videos when I was 17. I was arrested for it when I was 18. And I was sentenced for it when I was 19.

- And how much time did you get for that?

- I got three years in six years on extended supervision.

- Did you fill out this form?

- Yeah.

- My template is the one not filled on so what Connie, did you have private firm.

- Brokheim.

- I have a question about your sentence I'm looking at the paperwork. And it says that, you were at state prison one year and then extended supervision for two. Was there a violation?

- No, there was three, three separate counts.

- In consecutive or?

- Given they gave me one year in a row for each count.

- Understood, thank you.

- Officer is that accurate?

- Yes, that's accurate.

- Okay thank you. I guess I'd like to know you're currently living in a Ashwaubenon and you're wanting to move to Green Bay, why do you want to move to Green Bay?

- I'm just trying to move anywhere but I was born and raised in Green Bay, all my family's here. We have like one uncle living in Texas. I'm just staying with my brother. He took me in right when I got out, is just trying to give him a place.

- When did you get out?

- April 23rd 2019.

- So you've been staying with him that whole time.

- Yes.

- Okay. And Ashwaubenon approved you to live there.

- Yep.

- Okay

- And you're employed right now?

- Yep, I work at 4G Plastering full time.

- Anybody have any other questions for those wanting to trade in?

- So we'll discuss your treatment, would you like that in open or closed session?

- Open is fine.

- Okay. So you're currently in treatment, is that correct?

- Yes.

- And who is that through.

- Hanger enterprises, the guy is in Spartle.

- Okay.

- I was wondering--

- Yep I see that. And how long have you been attending?

- Since a couple months after I got out, I got into debt treatment. And then as soon as that's completed, I was taken or I'm going to it doesn't matter if I have to, I want to.

- So, what have you learned during your treatment?

- I learned a lot about the offense cycle and how every individual lives a certain way. And I'm learning to like, look at that and see what was wrong with it and see like, what in my head was making me think that, that was okay, and where I was at with other things that would kept me or make me go back to the pornography taking in week by week in there.

- And how long do you think you're gonna be in that class still?

- I have, there's going to be a couple months, I have a few more slides to get through.

- Okay.

- Are you doing those in Milwaukee or is that something local?

- That's right on university.

- And you see the companies are marking it.

- Yeah.

- Any other questions? Would anybody like to make a motion?

- Oh, I'm sorry, Is there anyone in here speak for him? Yes, you may come up. State your name please.

- Richard, Richard Hendricks III. And I live, I'm his brother, that he lives with. And we just planned to give him a year with me. So I took him in, I made sure he had set up and has a path to success to like have a supportive relationship to live with. So he didn't have to worry about that, till now. No transition.

- Sure.

- And I work with him, but he's never late, he was there every day, he stays late. He works on the weekends to get over time.

- All right.

- No questions, thank you.

- Okay, thank you.

- I did have one more question for you. Are you allowed to have access to internet?

- No.
- Do you have a cell phone?
- Yes.
- No internet on your cell phone?
- No, it's very cheap.
- Okay. All right. Anybody like to make a motion?
- I'll make a motion to approve address specific for a period of 90 days, and we'd ask that you come back and provide proof that of your continued work with the company as well as attendance. At the treatment--
- Okay.
- okay, I'm sorry I didn't say that.
- Is there a second?
- I'll second that motion.
- Motion passes three to one.
- All right, you're approved to move to your address specific.
- Cool, thank you.
- Thank you.
- Thank you.
- Next on the agenda is Joshua Dorian. Want to assure us this is your first time appearing before us?
- I believe so, might have been here, 2008 or nine not sure. It's been a while.
- I had a spreadsheet that he appeared in a way but I had no other to take from that--
- Okay, 'cause I'm like, I don't understand that so.
- Okay.
- All right, so we'll start off with... Alright, so you're looking at moving to 334 South Chestnut, is that correct?

- That is correct.

- And you're currently homeless.

- Yes.

- How long have you been homeless?

- About, six weeks, four? A couple of weeks, two, three weeks. I was currently at the attic, the TLP I get released from prison in November 24th, a couple days before Thanksgiving. I was at the TLP for 60 days, and that's the most time they can give me there.

- Okay. All right, we'll ask you to tell us about what you were convicted of, again please don't refer to the victims by their name or relationship.

- Okay.

- So I have a second degree sexual assault of a minor conviction in 2005, crime happened July 4th 2004. I was at a house party, I was 20 years old. And I had sex with a 15 year old female. And do you need to know of other crimes or just the sexual assault?

- I mean, did you know she was 15 old?

- Yeah, she was my little brother's age. She was a neighbor at my mom's house. So I'd seen her like occasionally and lived with my mom at the time. But on my own whole life pretty much so. I was there with my little brother, my girlfriend at the time. Came down to an altercation with her boyfriend and threatened them with a gun.

- You threaten them--

- I threatened them with a gun, yes. And she asked him to leave, and I was under the influence of drugs and alcohol, not that I'm making an excuse for anything but my state of mind that time was to get back at him some more so I pursued sexual intercourse with her. And then having sex with her. It was only for that night, I ended up getting arrested that night he went down to... Well he went somewhere and called the police. The police showed up and I got arrested that night. I didn't know anything about sexual assault, until maybe I can't say for sure. Within a week, I was in jail. So sometime within a week of being in jail for the gun charge turned on with a gun. They came and questioned me about the sexual assault and had a plead deal, no contest maybe? I'm not quite sure, I took responsibility for my actions admitted to having sex with my PO on the statement and stuff like that. I got three in, three outs on that sentence rank and current my relocation time.

- But then did you do it again?

- That is correct.

- So yeah, learning from that.

- That's true. So I got out of Mowate and my second crime was against my stepdaughter.

- Oh, no relationship.

- I'm sorry, sorry, you're right guess an 11 year old female I ended up taking pictures of her vaginal area. And, the next morning I was confronted about it and I was under the influence of alcohol. I do not remember that, what happened that night. When I was confronted in the morning by the mother. And when I looked on my phone, I saw the pictures. And so I told her, turned myself in. And that's what I did, I turned myself in, there were statements to my guilt, admitting to the pictures and come later on, I guess. I'm not quite sure I don't remember what's in the criminal complaint but I supposedly exposed my genitals to her. I've been asking them to find my criminal complaints. So when I took responsibility for everything I said, whatever just happened happened, I don't remember. There's no reason for her to lie. And so I pleaded no contest to the plea bargain there for me was like open plea bargain I was augmented or argued at sentencing.

- And how old were you at that time?

- I was 28.

- Is that accurate? I think there's some things that are left out here in regards to the first sexual assault in 2004. At the house party that he had referenced the victim had told investigators that she had consumed alcohol and blacked out. When she woke up, she found the suspect on top of her, having intercourse with her. She tried to push him off, and he covered her mouth with his hand told her to be quiet that it was fine. She was eventually able to push him off and get out of the room, so I think that's important to note.

- Is that's where the use of force comes into plea? Because that's the charge for the use of force.

- Yeah I agree with that is what it is.

- Okay, okay.

- I'll take responsibility for that, I'm sorry. Well, 15 years ago, I haven't read the criminal complaint. There is a use of force.

- I have a question, you said that you became homeless and then went to TLP.

- No, I was at the TLP when I got released from prison.

- Okay.

- And now currently homeless, stay in a motel. Have been employed my whole time that have been out, I got a job, my secondary job so have been employed since then.

- Where are you working?

- Calvins, it's a bottling manufacturing plant.

- What about support?

- Yeah, I got a couple of brothers in Green Bay. I'm trying to mend those relationships and it's not going that great otherwise I'm on my own. So my family I have left is just my nieces and nephews and stepson.

- If we would like to talk about your treatment would you like to do that in open or closed session?

- Open is fine.

- Okay, so it looks like you've done some treatment?

- I completed SOT two with Kettle Moraine in 2007 from my first offense. And I did Africare through family services well I was on extensive supervision, and then I re-offended. And right now, I'm currently in treatments through the Hanger enterprises.

- You have documentation?

- Yeah, I have. That's my completed program, I was at Kettle Moraine.

- This one, this is a letter here from Hanger enterprises indicating that he has been attending weekly groups since March 3rd, accepts responsibility for his offense and has participated in the group offering feedback and homework.

- This is a? Program made in referral.

- Program made in referral? Is that from the Department of Corrections?

- Yes, Kettle Moraine correctional institution 2007.

- Okay, completed aftercare recommended July 31st 2007, you enrolled in it in November 2006. All right. If you want, do you need them back?

- No.

- I think we need a copy.

- Yeah I can take one of these.

- And this is my advocator.

- Sorry, sorry.
- I'll wait.
- Okay, yeah.
- This is my Africare that I completed through family services which ended in 2012.
- As a family services treatments summary in closing Do I have to give you a summary of this?
- Yeah.
- Oh, okay.
- All right.
- Unless you want everybody else to three of these were taken we will make a copy.
- Do you wanna look at your reference?
- All right, this is a sex offender program report, everything was pretty much low. The presence of any of these items listed below may indicate in increased risks of sexual offense. So, yeah criminal thinking, decline in problem solving, increase in impulsive reckless behavior isolation, rejection from support system, unstable or absent intimate relationship, negative social influences, angry sexual preoccupations, substance abuse, frequent areas visited by children. And this is dated from November 15th of 2012. Also no further sex offender treatment recommended at that time.
- We're gonna have these reports for you.
- So, I had just read it clear.
- Yeah.
- You had a 2012 treatment for SOT treatment.
- Yes.
- And then you, right currently you're seeing Jim Drink.
- No.
- Or no, you have no treatment right now.
- I'm in treatment right now. I just got accepted in the treatment couple of weeks ago.

- And what about sex offender only? Or is it okay? What about drugs and alcohol?
- No, it's usually like, all encompassing within because it's part of the offense cycle. So it's like, kinda treated but not like targeted in sex offender treatment, does that makes sense? I guess like it's like a subsidy of treatment as far as taking an AODA or anything like that I've never done that.
- You plan to?
- Right now it's, they want me to do the SOT first I believe that as part of my supervision rules, I will be doing it eventually.
- Or anger management, tried anything like that.
- No, I wasn't required to take anger management. When I was incarcerated you know, you go through the system, they evaluate you on the two programs I was recommended for SLT, of course and then AODA.
- So what would you say your triggers are?
- Now just being like yeah, yes being like overwhelmed with stress. Things not going right, depression, feeling rejection or loneliness at the time on my current crime I did, I found out my fiancée was cheating on me. Not that it makes an excuse for anything, it's just one of the major stress factors in my life at that point in time and also being an unhealthy relationship. You know, I don't, I haven't drink or done any drugs have also been out first I'd just test for my job and for my probation, whichever brought documentation, I have it. So, yes.
- What about the lack of your support system? How do you think you're gonna handle that? Like if something was bothering you, who, like who would you turn to?
- I got one kind of friend that I talked to like over the phone I got a couple people I still keep in contact with in prison and email and stuff like that now I get that accessibility and I still have some friends in prison and I can keep close contact with that I've talked to a couple times a week.
- Anyone at work, or a little bit closer to you.
- This point in time, no.
- Have you ever attended the Circle of Support group are you familiar with that?
- Years ago, yeah, I was actually part of a ministry of Nagato in 2008.
- Mm.
- And they might still be part of that, over there on, I think it's in Packerland. this point in time, I'm just focusing on work, I work 50-55 hours a week.

- What shift do you work?

- 7:00 to 11:00. That's it right now, but I pick up overtime on Saturdays.

- Okay.

- What my concern is, is hearing the list of triggers that you have, kind of all the situations, situations are the same: lack of support, you're kind of isolating yourself. Working is good, working is good, it keeps your mind off of certain things You can focus but then not having a balance.

- Mm Well as far as for lack of support home I'll start treatment. So I have, you know, weekly sessions. So I have that also. And my probation officer is very flexible and stuff like that so I can call and contact him anytime.

- And you would feel comfortable.

- Oh yeah, I've contacted on many times I've been on line like so I've been on my own so I get on. So going and doing everything by myself. You know, like I said, I've got a job and a car. I make good money, now I'm paying \$350 a week to not live on the streets, staying from hotel week to week. Also, it's not like I'm slacking off or anything like that. You know, I'm working hard and trying to do everything right so just stay out here. Getting this residence approved would be a great relief of the burden, you know, trying to find somewhere to live we all pay a reasonable amount of rent.

- Would anybody like to have any further discussion or make a motion?

- Oh, is anyone here to speak on your behalf?

- No.

- Okay.

- I'll make a motion to approve Address Pacific for a period of 30 days. You mentioned you're just going back into treatment right now.

- That's correct.

- Pardon.

- That is correct.

- Okay, and then to come back in 30 days with an update on your treatment.

- Right.

- Is there a second?

- I'll second that.
- Take a vote.
- I think it's your nail.
- And you get mine, I get to balance with that.
- I did too.
- Just like Chicago I get to vote twice.
- I wish we get a copy.
- Motion passes three to one.
- Okay, so you're approved to move to 334 1/2 South Chestnut Avenue. You will need to come back in 30 days and--
- Did you want me to--
- Bring proof review of your treatment tell us how it's goin'.
- All right.
- Thanks.
- So we'll need to appear back in person.
- Yes.
- That'll be next month's session.
- They'll send you a letter on it.
- Okay.
- Well, I'm homeless.
- We just approved you can move to that address.
- All right, well, that was the other issue was that address isn't going to be available until mid April as well as trying to go through the process now, in case I didn't get approved, 'cause if I didn't get approved I would had to find somewhere else.
- Mm.
- So now what do we do?

- Do we do it?
- Don't tell me that's gonna ruin everything.
- No, it shouldn't, it should be fine.
- We sort of fix it.
- No, we'll come back in 30 days. Proof of everything that was requested of you you've already been approved for that address. You just need to come back.
- Yeah.
- Okay.
- Kathy with the information--
- How were you gonna mail something to him?
- Yeah.
- Do you want a probation action tomorrow I can have it ready tomorrow morning.
- Yeah I can do that.
- Okay.
- All right.
- Okay, thank you.
- Thank you.
- Our next is Dustin Andre. And it looks like you're currently at the residence.
- Yes.
- And?
- I've been there thinking three years in July coming up here, I haven't been on paper since 2014. And I honestly was under the assumption that our house is enough feet outside the Van area. So and I've always stayed compliant. I never looked into it. And I've been put on probation recently for theft, or, I've sold a drill to a pawn shop, that's where this all came up.
- Actually I thought it was in outside of the border myself.

- Yeah 'cause I think, I don't know the feet exactly but our feet is like 1054 from the school property. And I think the man is 750 right there so,

- Oh, I'm sorry I'm thinking of a different story.

- Oh but--

- Okay.

- So I never had any thing come up with the registry or any local officials or anything. So I was always within the guidelines. And my agent didn't say whether I was or wasn't, I just had to put my paperwork in for you guys.

- Okay. All right. Well, we're gonna ask you to tell us about what you were convicted of and, again, don't refer to the victims by name or relationship.

- I was 19 years old. I met some females. The victims of my crime through another, buddy of mine and it was a weekend for me and two buddies and a couple of these girls that we had that, we all get together. They were 15, I didn't know they're underage at the time. I guess if I would have thought about that the moment, I knew there was a crime being committed, but that wasn't a thought we were all partying having drinks, turned into a sex party. One of the girls mothers came aware of what was going on and then called the police, which I was arrested the very following morning, early hours for three counts of second degree sexual assault. I took ownership for all of that, I was sentenced to 10 years for each girl concurrent three years and conditional confinement, seven on paper. Originally, the DOC had me set up to do the SOT to put the waiting list for so long--

- Do you wanna talk about what, other treatment? Okay I'm so--

- It's okay. Yeah. Did you fill your application out?

- For here?

- Yes, I did and I turned in a letter from origin about the scene.

- Okay. Cause you have sexual assault of a child a Class BC.

- That's what it was at that time.

- Oh the felony BC?

- The felony BC.

- Okay, okay. All right. Would that be accurate?

- Yes it's accurate.

- Okay, thank you. Any questions about his crime?

- No.

- No.

- Okay. So then with treatment, would you like to discuss that in closed or open session?

- Open is fine.

- Okay, go ahead and talk about your treatment.

- When I'd had got evaluated at Dutch Correctional they had set me up for SOT two, the waiting lists was so long, my release date was gonna come up in the middle of the treatment that I did not complete it in there. In 2005 I don't know where to take papers for that or not I did do the treatment with Tim Drake. and that reminded me when I heard her say that, the family services, was an outpatient program, I remember it was at night. Like I said, that was almost 15 years ago, I'm not really sure how long it lasted, what I would have done with the papers I would imagine my probation agent like building that up. I'm not currently on paper for the sexual so, I would imagine that records might be able to find something on that. I just turned in the paperwork for you guys in recent 'cause I just was recently on paper so I haven't had much time to locate or try to gather together too much information for you guys.

- And that was because of the theft?

- Yeah, I'm on probation for a year for falsely or for either calling the drill or receiving it, one of the two I forget which I applied to when one was ready. Basically, I received the stolen drill and conned it for some cash. I am currently under the care of Valley Psychiatric and I'm an LP, I'm 56 days clean from crack and alcohol today. So I do go to a lot of support groups, AA every day. IOP is on hold right now until April, I'm just over halfway through that program. I'm not working at the moment I'll be going back to work late May or beginning of June for mill coatings as a family owned company. Basically it's the off season we do finishing at level field we'll be doing like paintings like towers and steel.

- Have you worked there in the past?

- Yes. I still stay active. I have a child that I have at home with me.

- How old?

- 13 and she goes to school close to us at Franklin. I'm good with my agent I've done everything that's been asked of me.

- Anyone with questions?

- Question, just about your past actually from 1997 to 2001. I see a little--

- Yeah, I don't, I did. Reflecting on that, I think the '97 one would go back to a theft and believe I was 16 and somehow I got mixed up meeting an older guy and kind of became like a running mate. He was always wanting to hang out, he had a car, he was older, he could buy alcohol. We got drinking and I remember we did some breaking into some storage units of some sort. That's what caused that, there should be I think I believe like a 90 or a DD or batteries and so on I was pretty much living on the street and I was staying with a guy that I met an older guy, to another friend, we became drunk, him and his lady had problems and I ended up beating him up. That what's that charge was about. It's so long ago, yes, I was young. I'm just not that person anymore, I'm 38 now, I'm a lot more responsible. I've had a lot of years to straighten out my life. And I can say I'm doing well today.

- If you remember were drugs and alcohol always part of all your crimes?

- Alcohol, was always involved, yes.

- And so you're getting AODA treatment now?

- Yeah, intensive outpatient program at Bell come along with a regular attendance at meetings all around Green Bay.

- And how long is that gonna go?

- Well, going back I expect to have a graduation from their mid May.

- What about aftercare--

- There's a 90 day or 90 days, I believe they're 12 weeks of aftercare that'll take place right after that. So it'll be to the latter part of the summer for sure. And I see my regular psychiatrist on regular basis as well.

- Did we have documentation on that?

- I was gonna bring all of them, I just couldn't get it fast enough and--

- I just got his application.

- She yeah, my agent, yeah. My agent said it would probably be next month and I was rushing and then I got the letter in the mail, I said, hey, this is pretty fast.

- Okay.

- All right. Is there anybody who would like to make any motion?

- We got people who want to speak.

- Oh, I'm sorry, yes thank you.

- Just state your name and address please.

- Sandra Doublemint, 128 12th Avenue.

- And you're in?

- In US Merit 712 Carts Drive, Apartment 10 Pulaski.

- Just, he's come a long way I met him three years ago, and he said I have issues with drugs and alcohol. And he's almost 60 days clean.

- And that was just Oklahoma.

- In the last that, he's had a drug problem for the last couple of years, the drugs previously were not a problem for him.

- I picked it up in the summer of '16. Before that, I was just an alcoholic So the last three years have been rough for me and I haven't been on paper or anything throughout that was part of my issues on that drill I'm looking for money. But otherwise, all my convictions have all been alcohol based.

- And he didn't state this method, but I mean, his years growing up, he comes from a long history of alcoholics.

- And are you living with him?

- Yeah.

- Okay.

- Yeah, yeah. We're in a relationship and his daughter's living there with us as well.

- Okay.

- My parents own the home. I will say that my mom did call when he moved into the house, to check to see if there's any issues and was told as long as he was not on active paper, that there wouldn't be any issue. So that's why we did not pursue it at that time.

- But now he is?

- I think it was a couple years ago, so that was before our time.

- So that's why he, we didn't come before you sooner than this.

- Okay.

- I would just like to add the same thing. I'm the mother of his child, and she's been residing with him now since he's been sober and going through all the treatments and

everything is going really well. I'm very proud of him, he's really come a long way. And I think that there's only bigger and better things for him in the future.

- All right.

- Thank you.

- All right.

- Anyone else? Anyone wanna make a motion?

- I will make a motion to approve address specific for a period of only, I hate to do the 30 days but we need your paperwork.

- I will be up on that.

- Because my concern is alcohol and drugs.

- And I can get that hands down, I just did not have the time to get the nurses to get the doctors to get the paperwork. But I can get that done.

- Will you be able to get it within a month from today?

- I absolutely will.

- Okay. And it needs to be paperwork that shows your visits, your sessions, everything and anything since you have started treatments.

- Okay.

- Triggers.

- Okay.

- Is there a second?

- I'll second.

- Take a vote.

- Motion passes unanimously.

- All right, so you're approved to stay at the 128 12th Avenue, but you'll need to come back next month with the documentation that's requested.

- Is it the same date?

- It's the second Wednesday of--

- **Second Wednesday at four o'clock?**
- **I'll send you another one real quick.**
- **Okay, thank you.**
- **All right thank you. All right, next on the agenda is Edie Broadnext Jr.**
- **Hello.**
- **Hello.**
- **Okay, so you're currently at 1230 Waizey and you wish to remain there.**
- **Yes.**
- **Do we ask you to come back, have you been here before?**
- **Yes.**
- **His last appearance was in 2016.**
- **Okay so, let's start with why you're there before us approving it.**
- **I was in jail and I was supposed to be released to my sister's address and it didn't work out. They actually got her evicted. So I moved in with my girlfriend and my appeal said that I can stay there until I get approval or if not I need to find somewhere else.**
- **How long have you been staying there?**
- **Since January, I was released for a year.**
- **And how long were you in jail for?**
- **I was in a prison and then brought back to jail. But I was in jail 10 months. I was incarcerated a total of 34 months.**
- **And what were you in prison for?**
- **A violation on probation.**
- **For the original charges of sexual assault?**
- **No**
- **Okay.**
- **Your application is pretty vague. So that's why it's kind of hard to follow.**

- All right.
- All right, why don't, do we need, do you want him to go over his offense.
- Yes.
- It's been a long time.
- So, as you heard, go ahead and tell us about what you were convicted of how it came about, and don't use the name of the victim or the relationship.
- Okay, I was convicted of secondary sexual assault on a minor, I didn't know she was under age at the time. There was a kid involved, I found out that the kid wasn't mine, it was a big mess. I'm not sure how she's doing anything like that, we have no contact so other than that, since two, three years probation because there was a kid involved so, I was gonna take other time taking care of the kid until I found out that it was not so.
- And how old were you, sorry.
- I was 20. 19-20 somewhere.
- And she was how old?
- 15 at that time.
- Any further questions on the sexual assault? You kind of have a lengthy criminal history here. Kind of a lot of charges to review. So what are you? You're on probation right now?
- Yes.
- And what are you on probation for?
- What offense number.
- six.
- Is that what you went to prison for?
- Yes.
- And how long are you on paper for?
- I have a little over three years left.
- And then what did you serve jail time for? You said you were in prison then came back and served jail time.

- Okay, I was revoked because of an allegation. I had a physical altercation with my ex fiancé. So, I came back from prison in March 26th. So I was there until January eighth fighting that case--

- What was the result?

- I took a plea deal because I was tired of sitting there for disorderly conduct and trespassing. But that was another several documents stating that it wasn't even there.

- Any further questions on his charges?

- Yeah, it appears as though you have one prior failure to register?

- Yeah. My son started a fire, so it was all relocated at the time, and I never did receive it. So I didn't have anywhere to live at the time--

- You never received a letter for what?

- For the registry board.

- Right, but as a part of your plea or your trial, when you are convicted of a sex offense, the court notifies you that you have to register as a sex offender. There's a difference between moving into some place into a location and realizing I need to go before the board and I need to register every single time I move.

- Right. I was young, I didn't understand all this stuff. I was kind of down to the law.

- Well, you have a parole agent, don't you?

- At the time when I found out I'm not sure when took place.

- That was around 2008.

- 2008, no that's when my son had burned the house.

- Right, but when you moved you didn't register? You failed to provide information, same time. Filing date was 2009. So that's a concern because that's an ongoing obligation and forever.

- All right, a caution, yeah.

- Okay.

- And I've been on top of it since then.

- What about, okay because it does, in looking through everything I don't see enough, somebody please correct me about your--

- Oh no, we can't get there yet, nevermind.
- Treatment.
- Do you, would you like to discuss your treatment in open?
- Open.
- Open?
- Yeah.
- Okay.
- Okay, IOP and aftercare completed 2017.
- Yeah and I was supposed to get paperwork from my probation agent from, I don't think she ever did. I can either probably get it tomorrow or--
- You know, that's your responsibility to get stuff and provide it to us. When getting it has a pattern of behavior I'm seeing, in not registering, that's on you. Nobody can remind you.
- Okay.
- Also providing paperwork of everything you've completed, to support your request to move or to live in, the restricted area.
- Okay.
- These are all obligations that you have to meet in addition to that, with regard to 60W Lines, that's another concern and you have in your history, other drugs as well. Not a lot of follow through let's put it that way.
- Yeah, I'm not that same person anymore. I understand, I understand your concern.
- When was your last conviction?
- 2013.
- Well, there's this 2017 case, for--
- That was when I took the plea deal for disorderly conduct trespasser. 'Cause I've been sitting in jail for 10 months fighting the case, and I said I had all types of documentation with this, to say that I wasn't even there. And, my court days kept getting pushed back, pushed back, pushed back. So finally, I just got tired of not saying that I would just get rid of this battery because, they don't know, they had no proof of anything. So, I took the plea deal for disorderly conduct and trespassing.

- Now, help me understand this, this is a 2017 case it was filed in 2017. Were you arrested at the location and then brought to jail? Or was this something you received a notice about?

- Oh no, I went to see my PO and I was arrested that day. I had talked to him about it beforehand and then when I went to see him, I was arrested.

- When was that?

- March 29th 2017.

- 2018?

- '17.

- So you have been in custody from 2017?

- Until January 8th of this year.

- 2020.

- Correct.

- And you weren't released at all in between that time?

- No.

- Okay. I understand that's an issue.

- So when did--

- Yes I did.

- What's the problem here?

- In the county, people being kept in custody for appending pieces and being in for quite a long period of time.

- I lost my job, I lost my house--

- No, I understand that, I'm not, the thing is I'm not contesting what you're saying.

- Okay.

- Well, that is a community problem Sure that was your problem, but its also our problem.

- Right, exactly.

- Three years without.
- Yeah.
- Well, it was my understanding you were in prison, got released from prison and then went back to the county jail.
- Exactly.
- So he wasn't in the county jail for three years.
- Okay!
- He was in prison.
- Okay.
- Got released and went back because of this open case.
- Got it, okay.
- Exactly.
- All right. Okay, would anybody like to have any further discussion or make a motion?
- And you may have said this already, how long have you been at the current address?
- I was released January 8th.
- Okay.
- It's okay well, over six days.
- Okay. Are you on any type of medication, which was a vitriol or avit I can't figure the name.
- Called vivitrol?
- Vivitrol, yes, anything like that for alcohol?
- No.
- When's the last time you took a drink?
- It's been a while. I've been trynna get my life together. I was doing good before, I was revoked so, probably around that time.
- And where does your family, live your support system?

- I've got, a lot of family in.
- In Green Bay?
- Yes.
- And you're working where?
- I work at a Louisa company.
- Did anyone wanna make a motion?
- I will, I'll make a motion to approve address specific 1238 Waizey Street for a period of 30 days and check on how you're doing then to get documentation on programs that you're in and the treatment that you're going through that sort of thing.
- Am not into--
- You're not into any treatment at all.
- I'm supposed to meet with my PO next week. We're supposed to go over that case so, she may recommend something there.
- Okay, well come back in 30 days with whatever they recommend and let us know what's happening.
- Okay.
- Is there a second? Okay, so we need to have some further discussion. I would have seconded, but I don't like the 30 days.
- Okay.
- One he's been before us, this is now I think your third time--
- Correct.
- And every time we have approved you, and I mean, looking back at some of this, you know, alcohol was an issue but it never caused you to recommit a sexual assault charge. So, that's what we're really here for is to make sure you're not gonna re offend as a sexual offender so that's why I didn't second today.
- I wanna make a motion to approve address specific, period.
- I'll second that motion.
- We'll vote.

- Motion passes three to one.

- Okay, you're approved. You don't have to come back unless you decide to move from that address.

- Thank you.

- All right, thank you. Next on the agenda is Thomas Seneschal. Is that how you say it?

- Seneschal.

- Seneschal, okay.

- Afternoon.

- All right. So you're currently at 84 Kellogg and you wish to remain there.

- Yes.

- And you haven't been before us since 2012. So, why are you there without our approval?

- Well, I had been working for 20 years for Dean Foods, had complications with my health, which caused them to have me get approval from my doctor to come back to work, 'cause they had released me from work. Got that approval, went back to work. Then they told me that I had to go see their doctor, and it was only for six months so I was off for work for six months, no pay. Finally, we had a meeting, the union and I and appoint manager. And basically what they were doing, was forcing me to retire or they were gonna fire me and rather than using my pension, I took the resignation or retirement package. Got home and by then my place where I was living at, that Pool Street address that was all destroyed. The people that own the house, wanted to sell it. So that became an issue and I became homeless. The homeless came 2015, and I tried to get a job, nobody would hire me and my health issue was still an issue. I wound up living on the street in my van with my two dogs, that went on for two years. I had a court hearing for traffic at someone with the OV after court hearing or court office and a lady there was kinda concerned for me 'cause she heard that I was on this road, she put it on her Facebook and some lady came. Now this is without my knowledge, she put that out on Facebook, this lady in New Jersey, had place here in Green Bay tells me it's for rent. Now I didn't know nothing about this, I'm still living on the street. I finally kept in contact with her, she told me that I had a look-see for an apartment while I was homeless. I didn't think of anything of this nature. I was just thinking of gotta find a place to live and I need to make sure my dogs have a place, gotta make sure I have food. I got to know all the police officers and everything over Green Bay and I find that very helpful. So anyway, she said I had a showing, and it was like a shock to me 'cause I didn't know anything about it. I was like, wow. She says, well, let's go, so I end up at the 884 Kellogg Street went to the showing, there's people there before me, that were looking at the same apartment. And I didn't think I'd get it because they're there first to butt in. The lady that actually put it up on her Facebook contacted me again 'cause she, and other

people kinda help me out with a cell phone. And she contacted me and told me that I got the apartment. And I was like, all two years living in the dead of winter, all that kind of thing, you know, great. I didn't think about all this stuff 'cause my thing is like over 30, some years old and it's like, I don't think that anymore. That's a dead issue from the time that I was convicted and never was sentenced to any counseling or anything like that, and then a couple years after my conviction, they had passed this law that you have now, and it was like a shock to me 'cause you know, and I'm like, I didn't know, and then I showed up here 2012. I know. Was it 2012, or something like that? My first hearing, now that was a failure to register, which I had no knowledge of prior to, 'cause it was just fast. So, well now I'm here again, and I really would love to stay here. I don't have any of, criminal thoughts or anything, although I do have some prior charges that have come across of late and--

- Are you on a signature bond for those?

- Yeah, I still am. And it was \$10,000 the first time, and then the second time, they got charged for debt theft, misdemeanor. They knocked it down to \$1000, civil department. And they are keeping up with all that stuff you know, along with all this going on here now, I'm taking on, you know, getting everything in order and I just really would like to go back to what I originally was. I wanted that I filed whenever moving. And all that kinda thing. I don't think on those lines that I used to think. My mind is like I have people that'll help, how many people that need to get back and forth to work or not work to doctor's appointments and grocery stores I hope for they need help, I'll take them. I have nothing to do, I'm retired, I've taken that on and enjoy it. So, I you know, I'm just complying to what is needed here and I'll continue to do so. Because I found that also that this is a lifetime thing which hurts me back it's, it's like you know, I accept that.

- Do you want him to discuss his sexual assault?

- I don't think that's necessary.

- Okay.

- I have to prior made decisions that I thought is there not because of me, it's just I have to follow these for laws, I kinda of just they, it almost seems as though they want me to be that person. I tried to commit suicide because of all that.

- Sorry. I apologize. All right, I turned it off.

- I apologize to all the kids that I've affected.

- All right.

- Do you want to discuss treatment, I mean, I know that It's been so long so--

- I've never been in treatment.

- No, alright.

- Okay, does anyone have anything they'd like to talk about?
- No, nothing.
- Okay. You have somebody that wants to speak for you or against you?
- I just had surgery so I was out.
- Sorry.
- No problem.
- I'm getting old really fast.
- You will just state your name for the record, please.
- Thomas Ropeak, hi, by the way. I recognized pastor over there he knew me in hospice.
- You got a twin brother? I knew I knew him more than once.
- I first met Tommy a little over 3 1/2 years ago. And what he said about volunteering is true. We crossed paths helping an elderly lady in town here named Olga Cruz. She was an older native lady, she was an alcoholic, had a lot of issues, children that were doing cocaine, living off her and abusing her and just pretty much destroying her life. She subsequently died a few months ago as a result of that. He was helping her out. And so he and I first met, and you know, people talk when someone has a registry and so on. So I asked him about it.
- I could have answered all the questions he just answered for that's open and honest, he was about it. I do have a good education in history, clinical psychology, just not licensed in it. And if anything, he does not think like an offender, but he did slip into what I call a survivor mode. And I think that's what the recent charges are about his had issues with his insulin and not being able to get in pretty bad problem with the diabetes. As far as him, I've got four daughters. I trust him with them that way. He's a good man, heart the size of the Grand Canyon, he bends over backwards sometimes too far to help other people. And like I said, I've been on hospice. I'm currently in the nursing home. You just don't see me here. But I wanted to make sure I was here to speak on his behalf.
- Thank you.
- You're welcome.
- All right does anyone want to have any further discussion or make a motion?
- I'll make a motion to approve address specific and with no request to come back.
- Motion moved.

- Is there a second?
- Is there a second?
- Second.
- We'll take a vote.
- Motion passes unanimously.
- Okay, you're good to stamp that address.
- My peaceful twin brother works for you.
- Good luck.
- If you wanna look for him.
- You only ask for. Okay, I will, I'll check that out.
- There is no context for bigger, right?
- That's right.
- He's a good word maker in that regard.
- Next on the agenda we have Isaiah Woods. So, you were here back in November requesting to move to the 891 Shadow Avenue and what happened here? Looks like...
- The board wanted to see him get his assessment completed and suggested he'd reacquire that, 'cause he is in Brown County Jail.
- Okay, so, do we have documentation that you did this offender assessment?
- We've got a little hanger attached from followup.
- My PO actually sent a few guys as well stating what's going on.
- His PO sent us a letter?
- His PO send me this.
- Oh, okay, okay. Sometimes like when I get to a certain page, it like freezes and it's just a white page. So that's why sometimes I have a real hard time.
- If you can't pull it up I...
- I also, I do remember having to go through this assessment with my PO.

- Well first, that's kind of treatment, are you okay to discuss that in public?

- Yeah.

- Okay.

- It's fine.

- Sure, go ahead.

- Oh, no, my PO I do remember having to do this assessment, I've had UAs taken a couple of times in the past, drinking over a year like a few other cases my PO said you need to get your SOT treatment done. I'd prefer first and she wants me to know I've been going to him he's around town. Main thing was the house to the jail and I didn't have any proper treatment going on. This is not a permanent request either, I would like to be in my own apartment myself. And it's a support network, my auntie and uncle of course, like they're really good people and they'll be okay with it.

- Okay.

- Does anybody want to go over his crime and then since it looks like we approved him right, we just needed him to get the assessment It's hard to read all this--

- He was denied at the time because he hadn't had any treatment and he was just told to reapply.

- Okay.

- Okay, I don't understand that like--

- Since you, well, let's see. So you've been going since December, that's correct?

- Correct.

- Okay. It's March, so good two months. Then I will make a motion to approve address specific.

- Is there a second?

- Yes, I second.

- Okay we'll take a vote. Let's see, one, one. What is going on?

- I'll get to that part.

- Last January.

- I'm sorry, I forgot to see if there was anybody to speak on his behalf.

- You guys are taking the vote, or whatever, I mean I brought them, these are the two people that helped me out the most what it was like, living has been great.

- Can we have anyone who got the papers.

- Okay.

- Okay.

- But we will be.

- You okay?

- Yeah.

- Okay. So I apologize.

- No problem, I understand.

- Do the motion.

- Oh, yeah, okay.

- Oh, I thought I had it already came through.

- It did.

- It did but then I canceled it when-- I'm sorry!

- Motion passes unanimously.

- Okay, you're going to move to the 891 Shonto Avenue. And you won't have to come back.

- Okay.

- All right come back.

- Thank you.

- Unless you move.

- [Together] Unless you move!

- I will let you know when I move.

- Okay.

- Thank you for your treatment.
- All right.
- I had 18 1/2 years of service. I have a lot to repaint.
- All right Thank you, you two. Tell me we have Leo Sanchez Basilica.
- No speakers.
- Hello?
- Hello.
- All right.
- Or you're just not using it at all. Oh, you wanna share mine or not?
- I've read everything for it.
- Yeah.
- All right.
- Oh that was marked as the 19th, I thought that was...
- No.
- 2020.
- Oh here it is.
- Yep.
- All right, so you are currently living at the halfway house?
- I was but two days ago, I was given my papers. So, in the meantime, I've been staying with my mom.
- Okay
- And--
- All right, and you're requesting to move to 1239 Cloud Street.
- Yes.
- Okay.

- All right.

- You've been here twice before is that correct?

- Yes.

- Okay. Would you like him to go over his offenses again?

- Yes, why don't you go ahead and tell us about what you were convicted of, again, don't mention the victim's name or relationship.

- Okay I was convicted of first degree sexual assault with a child. I was to babysit a child. The person who gave me the child to babysit, this is weird without mentoring relationships, but okay? And they were supposed to be back by 10:00 p.m., they'd not gone back until like 3:00 p.m., but anticipating their arrival at 10:00. Well, before they had left, he had made us both drinks. And before he left and then we left, he said he'd only be gone for like maybe an hour and a half. Then as he left, anticipating his arrival back at 10, I had another drink. And it kind of just kind of spiraled out from there and I just kept drinking, kind of getting more frustrated with the situation that he wasn't there because I had plans that night, and he said that in return for me, babysitting he would buy me liquor which at the time I could not purchase, I was underage. So I agreed, and then at some point the child had peed herself. I noticed this because I put my foot up on the couch where she was sitting before and it was wet. So at that point, I asked her if she peed, she said, no. I asked her again then she said, yes, I'm like, okay, we'll go clean yourself up. And I thought maybe she would just go like change her clothes or something, but then I heard the bathtub faucet turn on, at which point, I was like, what's going on? So I go into the bathroom and then I see her at the bathtub faucet, just throwing water at her face. And I found this to be humorous, so I pulled out my phone and recorded a video so I could show her parents upon their return. That didn't go over so well because by the time they got home, I was pretty intoxicated, I didn't even remember, and I went to sleep. Oh, right, sorry. While I was, I took the video of her on there throwing water at her face, then I was like, okay, that's not how you clean yourself, you're supposed to like actually clean yourself. Then I don't know if it was like motor functions or 'cause I was so intoxicated I didn't turn the camera off. So then I helped her clean up. And I believe in the criminal complainant says I didn't use any soap or anything. And then after that, you know, she went and got dressed. I helped her dress and then that was the end of the incident. And then the next morning, the mother of the child asked to use my phone 'cause her and the father of the child, had gotten into an altercation and someone got pushed and I don't know they weren't returning each other's calls or something like that. And I gave it to her. And then she came back and said it locked. It locked around my phone, so I just disabled the lock and gave it back to her. And then I next time I was woken up I was woken by police officers and I was brought to jail.

- And did you plead? How did you plead?

- Yeah, I took the plea deal and I was given eight years three of confinement because the judge saw fit that I complete treatment inside the system. I was then waitlisted the

entire time I was in the system and then I got out and then I was in treatment with, I don't know the street, but it's right over there. I was in treatment there and then they switch providers. So then they had me switch over to another one, one I keep hearing people reference Hanger enterprises or whatever. And then I had to restart with them and then I was most recently put back into incarceration because probation violations. I had three violations, one of which was I have an absolute sobriety rule, and second of which was I was at a park third of which was I had maintained a romantic relationship without prior probation approval.

- Is the person of age?

- Who?

- Oh yeah.

- Day Din.

- Yeah.

- Okay.

- But that situation was I was invited to my niece's birthday party. I went there, and I kind of had like, misgivings about the location because I'm like, okay, Cameron Park says Park, but there are locations in the park they're like just big grassy areas. I don't really see it to be an issue. I really should have just asked and confirmed with my parole officer. Didn't do that, severe lapse in judgment. And after that, there was another probation officer at the party and her significant other, whatever brought beers out for everybody and he offered me one and I didn't want to be looked at or ostracized because I wasn't drinking. And I didn't want to go into all the details. And so at that point, at that point in time, I'm saw fit to just say, okay, sure, I was tempted in take a few sips and you won't get asked any questions or put in a very uncomfortable position. No, no, that's really not a good idea. And yeah, for that I was given a TRA at NSDF, So, I just completed that, I was waiting for two months to get into the program and it was a 120 day program for AODA thinking for a change to be so also completed Walk the Line and 24/7, that's why I was there. Also painted the interior the black extra curricular activities.

- Any further questions?

- Why the move?

- Why the move? Because after I got released, I lost the the place I have prior gotten permanent approval for 154 Burger. And after that I was placed at the TLP And so yeah, no listing.

- Okay.

- How much time was that between, when you were revoked and now?

- I was not replicated but I was given ATR and--

- ATR is what?

- Right, alternatives retraction.

- Okay.

- That happened in September, that incident and then I was given the ATR the same month and I just was released not even two weeks ago.

- Okay.

- Did I ask if I needed to talk about treatment and if we do, do you wanna talk about it and--

- Yeah.

- Some kind of added measure. Or do we have anything further we would like to talk about.

- Just want to make, keeps not cooperating. You, the person you are, you want to move in with is your girlfriend, correct?

- Yes, that's my girlfriend.

- And, what is her name?

- Jade Krieger.

- Okay, so she's the person who actually owns the property.

- Yes.

- Okay. And are you working?

- No, I'm fresh out but I recently enrolled in a logistics class which will be taking place starting the 16th of March and that'll be a four week program and then after that, they said I'm guaranteed an interview at multiple places where I can do some sort of clerical work. So that's my current go to thing and I'm also currently waiting on a referral from my PO in terms of treatment.

- For what?

- SOT.

- Okay. And is there anyone to speak on your behalf?

- Yes, I have my mother that is here.
- There was no scheduled speakers.
- Sorry, I wasn't sure on that.
- Yeah you're supposed to sign a little slip.
- Okay.
- So I would make a motion to approve address specific for a period of only 30 days. When are you supposed to start SOT?
- She says she's waiting back on the response from the program director or whatnot. So I'm not exactly sure where she's at with that as of yet. But as soon as she, you know, lets me know that it's available, obviously the schedule around that because I registered for the program.
- And right now you're living with your mother?
- Yes, currently, well, for the past few days since I've been out of the TLB.
- And that is not within the restricted area.
- I'm not entirely sure. But I know that if you don't maintain residency for longer than not residency, but if you don't stay somewhere for longer than 10 days, it's not considered as residency, so I figured out wasn't.
- Was it his PO that said that for him to stay--
- Yeah, my PO told me to stay with my mother.
- Yeah.
- Its just as general suggestion in life.
- Sure.
- Talk to the person in charge to make sure you don't suppose anything in error.
- Right, I spoke to my PO she told me the same thing.
- I would make a motion to approve address specific for a period of 60 days then and at which time you would need to come back here and provide proof that you are enrolled and attending SOT treatment.
- Sure.

- That you have, by then you should have completed your logistics class.
- Yes.
- Provide proof of that and any a proof you have with regard to interviews you've gone on things like that--
- Or employment.
- Employment.
- Yes.
- Is there a second.
- Yes I second.
- Okay, we'll vote.
- Motion passes three to one.
- Okay, so you're good to go to stay at the 1239 Klaus Street for six days, and then you need to bring back that documentation that we requested. with many of the line there.
- Okay.
- Okay.
- There's always gonna be somebody who's got a beer to offer for you.
- Beard to offer me?
- Beer, beer.
- Oh, beer! My bad, I'm sorry.
- Yeah, you can't get away from it, so--
- Right, No I--
- You got to get beyond thinking that people are gonna look bad at you if you don't take it.
- Upon reflection for those six months while I was incarcerated, I'm like, I'd rather have people look at me strangely, than be incarcerated again.
- Tell them you're on antibiotics and you can't drink beer.

- No one will know or?
- It works.
- Yeah.
- Okay.
- Just say no and--
- That also works. I will apply to those.
- All right, good luck.
- Thank you, appreciate it.
- Okay.
- Yeah, are you just here to visit?
- Yeah.
- I'm so sorry madam.
- Oh, okay. All right, then--
- Motion to adjourn.
- All right. Well, first we have to say that our next meeting date is April 8th at 4:00 p.m.
- Okay.
- Okay.
- Motion to adjourn, second to that?
- I'll second.
- All in favor.
- Aye.
- Aye.
- Aye.
- Aye.
