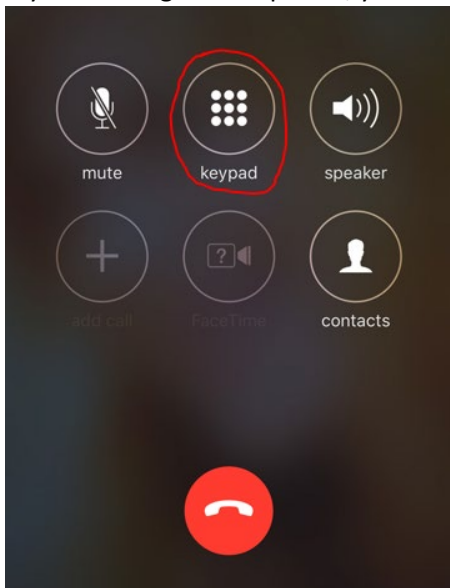

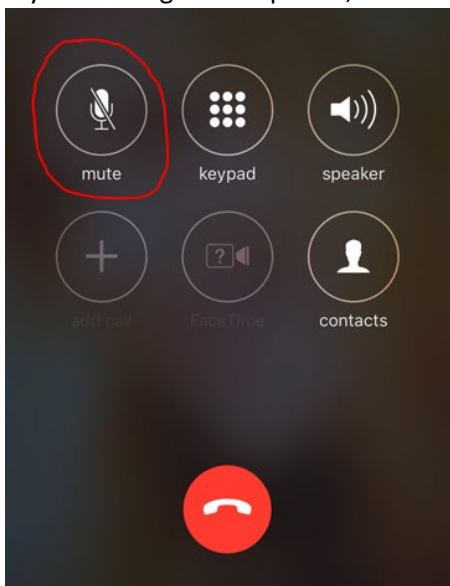
1. Wisconsin Open Meetings Law still applies

 - b. Committee/Commission/Board members will still follow *Roberts Rules of Order*
2. All zoom meetings will have a password in the instructions. Please enter when prompted.
3. Please log into the Zoom meeting 10 minutes before the meeting starts to ensure proper technology is working.
 - a. If you are a Board Member, please log into [CivicClerk](#) with a computer, laptop, or tablet device.
4. Once you are in the meeting please mute yourselves.
 - a. You may unmute yourself when you are called upon to speak.
5. Waiting room
 - a. When you call in, all callers/participants will be placed in a “waiting room.”
 - b. Persons on the agenda will be admitted to the meeting, and then once the item is concluded, the host will permanently mute you from the meeting (you can still hear the meeting).
6. Using Zoom with a tablet or computer
 - a. Tablet—you will be asked to sign in. Download the app either with the Apple Store or the Play Store
 - b. Computer—you will be asked to sign in. You may download the app or click on the link to open Zoom in your browser.
7. Registering
 - a. The host may ask you to register for the meeting. A registration link will be sent to you along with the invite. You’ll receive another email confirming that you’re registered for the meeting.

1. Roll Call. Ald. Scannell, Ald. Dorff and Ald. Galvin were present. Ald. Zima arrived later.

The meeting was called to order by Chairman Scannell at 5 p.m.

2. Approval of the Agenda.

Motion made by Ald. Scannell to take agenda item #11 before item #10 on the agenda.

Motion to approve the amended agenda made by Ald. Dorff; seconded by Ald. Galvin. Motion carried.

3. Approval of the minutes from the January 9, 2017 meeting.

Motion to approve the minutes made by Ald. Dorff; seconded by Ald. Galvin.

Motion carried.

4. Consideration with possible action a request by Green Bay Sportservice, Inc. to amend their "Class B" Combination License at 1265 Lombardi Ave. to include the Johnsonville Tailgate Village with attached deck.

The Law and Police departments had no objections.

Motion by Ald. Dorff; seconded by Ald. Galvin to approve a request by Green Bay Sportservice, Inc. to amend their "Class B" Combination License at 1265 Lombardi Ave. to include the Johnsonville Tailgate Village with attached deck.
Motion carried.

5. Consideration with possible action on an application for a “Class A” Cider License by Kwik Trip, Inc. at 515 W. Walnut St. (currently has beer license).

The Law Department had no objections.

Approved by Ald. Dorff; seconded by Ald. Galvin to approve a “Class A” Cider License by Kwik Trip, Inc. at 515 W. Walnut St. (Currently has beer license approved).

6. Consideration with possible action on an application for an available “Class B” Combination License by Copper State Brewery, LLC at 313 Dousman St. The Law and Police departments had no objections.

Ald. Scannell mentioned the outdoor beer garden would be fenced in with shrubbery.

Motion by Ald. Galvin; seconded by Ald. Dorff to approve an application for an available “Class B” Combination License by Copper State Brewery, LLC at 313 Dousman St.

7. Consideration with possible action on an application for a “Class B” Combination License by Timothy J. Rueckl at 704 Bellevue St. (Currently Greger’s Bad Habit Saloon).

Cpt. Laux mentioned there were some reservations. Cpt. Laux said the license stipulations were agreed to minus one item, which states: “The Licensee or any employee of a license establishment is prohibited from being under the influence of an intoxicant, or a controlled substance or an combination of an intoxicant and a controlled substance, while performing services or job duties on the licensed premises.” During the meeting with the Police Department, Mr. Rueckl made mention he would like to be able to enjoy a beverage with a patron. He assured the Police Department he was not planning on being intoxicated. Cpt. Florence approved the business plan, however, wanted the Council to be aware this item was not signed off on.

Ald. Galvin asked if this item on the license stipulation could be reworded.

Cpt. Laux said the license stipulation is a bit outdated and plans to work with the Law Department to reword this portion.

The Law Department had no objections to approve the application.

Motion by Ald. Dorff; seconded by Ald. Galvin to approve an application for a “Class B” Combination License by Timothy J. Rueckl at 704 Bellevue St. (Currently Greger’s Bad Habit Saloon).

Ald. Zima arrived to the meeting.

8. Consideration with possible action on an application for a "Class B" Combination License by Chanmina, LLC at 1423-1425 S. Broadway Ave. (Currently the Last Drop).

The Police and Law departments had no objections.

Motion by Ald. Zima; seconded by Ald. Dorff to approve an application for a "Class B" Combination License by Chanmina, LLC at 1423-1425 S. Broadway Ave. (Currently the Last Drop).

9. Consideration with possible action on an appeal by Amber Piette to the denial of her Operator License application.

The Law and Police departments recommended denial based on her record.

Motion made by Ald. Dorff; seconded by Ald. Scannell to open the floor. Motion carried.

Amber Piette - 1504 Plymouth Ln
Piette handed character witness letters to the committee.

Ald. Dorff asked what treatment programs Piette has went through and how it has changed her.

Piette said went through AODA class and assessment. She is clean. She has two small children, two jobs and works hard. She was 17 years old when she received her felony.

Piette wants to obtain the license to work at Lambeau Field and Tundra Lodge. Ald. Zima asked how long she has lived in Green Bay.

She moved to Green Bay eight months ago. She previously lived in Shawano County. She moved closer for her position at Lambeau Field, which she has worked at for 2 years.

Ald. Zima asked Piette to obtain a letter from their employer stating they are aware of her past and would like Piette to have a license. Piette said she would ask.

Motion made by Ald. Dorff; seconded by Ald. Galvin to close the floor. Motion carried.

Ald. Zima agrees that Piette has shown a change in her life. She has children and now leads a more responsible lifestyle.

Motion by Ald. Zima; seconded by Ald. Dorff to approve an appeal by Amber Piette to the denial of her Operation License application, contingent upon receipt of a letter of recommendation from her employer.

11. Consideration with possible action on the amendment to GBMC § 6.215 relating to Commercial Quadricycles.

The ordinance was approved in 2016 and is in regards to Quadricycles, also known as pedal pubs.

Asst Cty Atty Faulds discussed the changes.

One change made was the date an operator's license would expire. It was changed to Dec. 31 instead of May 31 as pedal pubs are a seasonal operation. Another change was in Section 3B regarding route approval. The permanent routes are to be approved/denied/amended through the Protection & Welfare Committee.

Ald. Zima suggested a member from the traffic department review permanent routes as well. Asst Cty Atty Faulds said this could happen internally. Changes were made in section 5 about temporary routes. These will now go through the police department to have a faster turnaround time. Temporary routes could be submitted up to three days before the event.

Ald. Zima asked why temporary routes would need such a short turnaround time. Ald. Scannell said special events could be a private event, such as weddings, birthdays and graduations. These might have not been planned as far in advance.

Ald. Galvin mentioned street closures. Also, the committee only meets once a month in the summer. This allows an avenue for operator's to prevent problems.

Ald. Dorff moved to approve, with a replacement of a sentence in section 5. She wanted it to read: "No licensee shall operate a Commercial Quadricycle on a street closed off to public traffic, regardless of whether the street is included an approved route."

Motion by Ald. Dorff; seconded by Ald. Zima to approve the amendment to GBMC § 6.215 relating to Commercial Quadricycles with revisions. Motion carried.

10. A request by Brenda Staudenmaier to rescind the resolution authorizing fluoride chemicals in public drinking water.

The police department had no position on the topic. Cpt. Laux was excused for the remainder of the meeting.

Motion made by Ald. Galvin, seconded by Ald. Dorff to open the floor. Motion carried.

Ald. Scannell mentioned this is a heated topic and asked everyone to remain civil and focus on the ideas and science.

Brenda Staudenmaier-423 S. Van Buren St.

Staudenmaier is a resident of Green Bay. She is also a certified WI Dept. of Natural Resources Drinking Water Operator and Waste Water Operator. She is a Certified Hazard Walker through OSHA. Her continued education is in Environmental Engineer Water technology with a focus on human health and water solutions. She was recognized in 2016 by the White House for her work.

Staudenmaier said fluoride was introduced to Green Bay's water system in 1957. She said it is a chemical that does not occur naturally. It has been sold as something that is good for our teeth, but it is a contaminate that can promote disease.

She submitted 196 studies with a petition to the EPA showing fluoride is a developmental neuro-toxin that can cause learning disabilities.

Staudenmaier noted a city in Maine recently removed fluoride in their water. Their reasoning was that 40 percent of American adolescents are exhibiting some degree of dental fluoresce. Too many people are getting too much fluoride.

Staudenmaier recognized this is a controversial topic and people lean towards the side of caution. The science being used to defend the claims are outdated and biased.

She further presented arguments regarding removing fluoride in Green Bay's Water System.

Lacey Kuehl at 1002 Estes Dr. in De Pere spoke against fluoride in the water. She grew up in Green Bay on Crooks St.

Ald. Zima asked Staudenmaier if water filters take fluoride out of water. Staudenmaier said there are expensive ones that do, but water filters like Brita do not.

Nancy Miller, a Dental Hygienist, spoke in favor of fluoride in the water. Mat Cresipin, Associate Director at Childrens Health Alliance of WI, spoke in favor of fluoride in the water. He had a PowerPoint presentation.

Martin Zahariev, a Green Bay resident at 560 Fair Winds Ln., spoke against fluoride in the water.

Dr. Paula Krum a Periodontist and an Ashwaubenon resident at 2456 Ingold Ct., spoke in favor of fluoride in the water.

Andrew, a Certified Water Operator from Marinette, spoke against fluoride in the water.

Keith Decker, a Green Bay resident at 2821 Bristol Mountain Trl., spoke against fluoride in the water.

Nhia Yang, a Green Bay resident at 1022 Pine St., spoke against fluoride in the water.

Jenna Linden, 9 Cherry Ct. Appleton, WI, spoke in favor of fluoride in Green Bay. She is a Dental Hygienist in Green Bay and currently a Clinical Director at the Brown County Oral Health Partnership.

Lisa Hanson, a Green Bay resident at 708 Kellogg St., spoke against fluoride in the water.

Michael Schwartz-Oscar, a Green Bay resident at 322 S. Van Buren St. and Executive Director of Oral Health Partnership, spoke in favor of fluoride in the water.

Nancy Quirk, General Manager of Green Bay Water Utility, spoke in favor of fluoride in the water. She is an engineer and has been in the drinking water industry for 30 years. She said state Water Utilities follow the DNR codes and are regulated by EPA and the Public Service Commission. Green Bay's Water Utility follows the Safe Drinking Water Act recommendations. Green Bay's Water Utility adds fluoride based on section NR809.74 as regulated by state statutes.

The standard for buying our fluoride is the AWWA standard B703. This on file and information is available to view at the Green Bay Water Utility.

The amount of fluoride found naturally in the water is .1 to .2 mg per liter. Green Bay does add fluoride to a level of .7 mg per liter. Quirk said this is the lowest level the CDC recommends a city can go to ensure that we are protecting our teeth. Fluoresce can occur if more than 2 mg per liter is added to the water.

Quirk stated the pumps are set to eject .7 ppm. If the pumps release too much fluoride, it shuts off. The fluoride content is monitored 24 hours a day.

Fluoride in water is recommended by public health, medical and dental organizations. The US Surgeon General said water fluoridation was the best thing that has happened in the country.

Quirk serves on the National Committee for the Water Utility Council of American Water Works, which stays closely in touch with science and perform studies to regulate the standards.

Ald. Scannell asked if the amount of water you drink can have an effect.

Quirk said the amount was based on normal drinking habits. Some do drink more and some less. This is why the amount added into the water system was lowered due to exposure people have to other fluoride.

Ald. Scannell asked how a fluoride spill would be handled.

Water Quality Manager Hardwick said a spill would be contained in the dosage room and the local fire department would be contacted for proper disposal.

Chuck Decker responded stating he has seen a spill and it had to be addressed with hazmat suits and gas masks.

Quirk said the amount of fluoride is a meniscal amount, amounting to 42 seconds over the course of two years. Quirk said her decision is based on the best health advice available. However, if the Common Council makes a decision to take it out she will follow.

Ald. Galvin asked if the Water Utility monitors for lead and arsenic. Quirk said it is monitored.

Ald. Zima asked if she has looked into the communities that have removed fluoride in the water.

Quirk has not been in contact with them, but will research.

Chuck Decker, a Green Bay resident at 2821 Bristol Mountain Trl., spoke against fluoride in the water.

Keyundray Schultz, a Green Bay resident at 3647 Glenhaven Ln, spoke against fluoride in the water.

Dawn Craft, a Green Bay resident at 2040 Farlin Ave. and a WPS Service Analysis, spoke against fluoride in the water.

Carrie Stempski at 2829 E. Pennwood Cir., a hygienist who is now in management, spoke in favor of fluoride in the water.

Dean Pigeon, a Green Bay resident at 428 Menlo Park Rd, spoke against fluoride in the water.

Anna Destree at 3616 Stanford Dr. New Franken, Interim Health Officer of the Brown County Health Department, spoke in favor of fluoride in the water.

Miriam Owen, a Green Bay resident at 1320 E. Walnut St., spoke against of fluoride in the water.

Staudenmaier, who brought this forward to the committee, reiterated fluoride is a pesticide and an enzyme inhibitor. Staudenmaier asked on behalf of the citizens of Green Bay to have it removed from our water.

Motion made by Ald. Dorff; seconded by Ald. Galvin to close the floor. Motion carried.

Motion by Ald. Scannell; seconded by Ald. Dorff to take a ten minute recess. Motion carried.

Meeting resumed 10 minutes later.

Ald. Zima said those who spoke were speaking from the heart and with intelligence. Ald. Zima wants to respect individuals rights, however, cannot think of a way to offer both choices to citizens. He would not be able to make a decision at this time. In his personal experience, he has not been hurt by fluoride. He was taught to brush and take care of his teeth and not sure if the fluoride helped or not. He was open-minded and wanted more time to review the information.

Ald. Dorff had great respect for those who spoke tonight. She wished one person could come up to the podium and said well there is this, but also this. There were both sides of the spectrum. She would now have to look and decide for herself and be responsible and make a good decision for the community. She was not ready to make the decision that night. She has been a child advocate for the last 38 years and helped bring oral health into the Green Bay Public Schools. In a perfect world, it would be ideal to allow a choice of fluoridated and non-fluoridated taps, however, it would not be feasible. She sees both sides of the debate and would look further into the information to make an informed decision.

Ald. Galvin appreciated the passion of those who spoke and self-educated themselves on the subject. If it was just about tooth decay, it would be an easy answer. However, there are other factors to take into consideration. Ald. Galvin would like more time to review the studies further.

Ald. Scannell said he was leaning a particular way. As an alderman, Ald. Scannell relies on the staff to make an informed decision. He felt the expertise in this case is the established community. However, he will study the information left a door open to change his mind.

Motion made by Ald. Dorff; seconded by Ald. Galvin to hold until the Feb. 27 Protection & Welfare Meeting a request by Brenda Staudenmaier to rescind the resolution authorizing fluoride chemicals in public drink water. Motion carried.

Motion made by Ald. Galvin; seconded by Ald. Dorff to adjourn meeting. Motion carried.

Jillian Stitman was not present at this time. Motion made by Ald. Zima; seconded by Ald. Galvin to deny an appeal by Jillian Stitman to the denial of her Operator License application and to reapply if she is still interested in obtaining one.

Ald. Zima addressed concerns of its location.

Ald. Scannell said the Committee could seek feedback from the alder on the Council floor at next Tuesday’s City Council meeting.

Motion made by Ald. Dorff; seconded by Ald. Galvin to approve an application for a “Class A” Liquor and a Class “A” Beer License by Tikapur Petroleum, LLC at 2056 Main St. (Currently Main & Mason, LLC). There were no objections and motion carried.

7. Consideration with possible action on an application for a Class “A” Beer License by Tikapur Petroleum, LLC at 2115 Main St. (Currently Main & Mason, LLC)

The Law and Police departments had no objections.

Motion made by Ald. Dorff; seconded by Ald. Galvin to approve an application for a Class “A” Beer License by Tikapur Petroleum, LLC at 2115 Main St. (Currently Main & Mason, LLC). There were no objections and motion carried.

8. Consideration with possible action on an appeal by Christopher Daley regarding his dog, previously discussed at the Feb. 13 P&W meeting and placed on hold.

Asst Cty Atty Faulds recapped from the Feb. 13 meeting. As stated at last meeting, the dog has been declared dangerous by Officer Meves, and the owner Christopher Daley appealed the decision. Feb. 13 was the hearing where the facts were presented to the Committee. New information has come forward since the last meeting. Asst Cty Atty Faulds presented an e-mail sent to the Committee members and entered it into the record.

The e-mail from the Green Bay Police Department stated on Feb. 18, Daley’s dog was loose in his yard when it attacked another dog that was on a leash, as it was being walked by its owner on the sidewalk. The Police Department learned of the attack on Feb. 21 and Animal Control Officer Meves issued a citation and seized Daley’s dog, which is now secured at the Bay Area Humane Society.

Asst Cty Atty Faulds noted Mr. Daley was not present at meeting.

Ald. Dorff and Ald. Galvin moved to denied.

Ald. Zima said he felt very uncomfortable last meeting and said the only reason it went unanimous was that the dog was to leave the city during the decision. The decision was placed on hold so the owner had an opportunity to make an area for the dog to keep her confined. Ald. Zima was in full support of the motion of denial.

Asst Cty Atty Faulds said the Committee has to put into the record the findings of fact on why it is or is not declared dangerous, and the motion one way or another to ensure the record is clear.

Ald. Zima suggested: "In light of the fact the dog has been in four biting incidents in the past year and the owner did not take the necessary precautions, we are declaring the dog dangerous."

Ald. Dorff asked Officer Meves how this has happened and a possible explanation.

Officer Meves said the dog Reba was running loose when the incident happened. A gentleman was walking a leashed dog by the residence. It was a little morkie, a Maltese Yorkie mix, which is a small dog. Reba was running loose and ended up pinning the dog down. Reba caused two pretty big bites to her. The owner of the morkie went to open the dog's mouth and at that point has sustained some scraps. He wasn't sure if it came from the dog during that or while he was down on the ground wrestling the dog. It was a struggle to get the dogs away as he had to hit and kick Reba to get the dog off his. There was no fence made at the time of the incident and the incident happened on the sidewalk. Mr. Daley had given a gift card to the gentleman and asked him to not call the Police.

Officer Meves said she was informed of the situation on a Schmitt Park neighborhood blog. His wife posted a blog that read beware of dog. She posted this blog and everyone said you needed to contact Animal Control. Officer Meves said she reached out to the owners. She confirmed it and met with them and assessed the situation.

Officer Meves then immediately seized the dog, who is now at the Bay Area Humane Society on hold.

Ald. Dorff asked what happens to the dog now.

Officer Meves said based on the Committee's decision tonight, if the dog is declared dangerous it cannot remain in the city. But during this decision process, the dog was not supposed to be in the city. Officer Meves said Daley did

construct a 4x4 makeshift fence, which Officer Meves was able to lift up the bottom of the fence.

If he doesn't reclaim the dog within seven days, Reba would have to be put down. Officer Meves said Daley was considering having the dog stay with his brother in California.

Ald. Zima asked if Daley was cited.

Officer Meves said yes, he was recited for "Animal not attended within five-feet of right away."

Asst Cty Atty Faulds added the findings of fact should meet the elements of section 8.105.

Ald. Dorff asked if the fourth incident was off the owner's property. Officer Meves replied it happened on the sidewalk.

Ald. Zima thought there was a more serious violation as he did not have the dog leave the city and defied the Committee's ruling. It was Ald. Zima's understanding that the dog would leave the City while proper confinements were put in place and the Committee was to review the area.

Ald. Dorff said the Committee couldn't make the owner do it, but the Committee thought he would have.

Asst Cty Atty Faulds clarified that the dog did have to be outside of the city during the pending hearing. However, the Committee could not put stipulations like building a fence.

Ald. Dorff asked to do another finding of fact.

Asst Cty Atty Faulds said if the dog is considered a dangerous dog, then it would also have to be qualified as a menacing dog.

Ald. Scannell suggested starting with Ald. Zima's motion that the animal has four incidents of injuring animals and people while not on the owner's property.

The final motion became: The animal has four incidents of injuring animals and people while not on the owner's property, we declare the animal a dangerous dog that causes injury in a menacing fashion. Therefore, it meets the definition of a dangerous dog and therefore, needs to leave the city.

Motion by Ald. Zima; seconded by Ald. Galvin To deny the appeal of Christopher Daley, 2747 Humboldt Rd., to the declaration of his dog being labeled as a dangerous dog under the City of Green Bay Municipal Code 8.105, Sec., (1), (2),

& (3), based on the adopted findings of facts and conclusions of law announced at the meeting. Motion carried.

9. Consideration with possible action a request by Brenda Staudenmaier to rescind the resolution authorizing fluoride chemicals in public drinking water, previously discussed at the Jan. 30 P&W meeting and placed on hold.

Captain LePine was excused for the remainder of the meeting.

Ald. Zima said he did watch a film that was suggested at last meeting. After watching, Ald. Zima asked if fluoride was good for teeth, then why was it being ingested into the whole system. He previously thought fluoride was good, but was no longer convinced it was. He thought fluoride can be found in other ways.

Ald. Scannell asked if the staff had items to provide.

Nancy Quirk, General Manager of Green Bay Water Utility, addressed the committee.

Quirk spoke with a person from the Water Department of Montello, a community that no longer has fluoride in their water supply. The gentleman said money was the reason why fluoride was given up. They had other things they had to take care of in their water.

Ald. Zima recalled when smoking was a positive thing. Ald. Zima said those against fluoride made a very compelling argument.

Motion made by Ald. Dorff; seconded by Ald. Galvin to open the floor.

Ald. Scannell said this is City Business. The goal is to give the Committee answers and input. Since there was already an open forum, if the information is repetitive, he would let them know. The goal is take the public's information, discuss amongst ourselves and make a decision.

Jillian Stitman addressed the Committee and if would be able to speak on behalf of her Operator License denial.

Motion made by Ald. Zima; seconded by Ald. Dorff to reconsider an appeal by Jillian Stitman to the denial of her Operator License application.

4. Consideration with possible action on an appeal by Jillian Stitman to the denial of her Operator License application.

Motion by Ald. Dorff; seconded by Ald. Galvin to open the floor.

Jillian Stitman
2185 King James

Stitman said she wanted to appeal the denial since she was denied on a felony that occurred 10 years ago. She is almost 35 years old and has changed since then. She has not had a record since that occurrence. Since then, she graduated from college twice.

In August 2013, she was hit by a train. It took a year to recover. She had a brain injury, which has placed limitations on the jobs she can do. Currently, she is a server. The promotion would mean a better income.

Stitman said she made a mistake 10 years and it is unfair to use something she did one time against her. She is completely different now.

Ald. Dorff clarified that if the law states if a person has a felony, it is required that the operator license be denied. However, the Committee can overrule that.

Ald. Dorff asked where Stitman works.

Stitman said she works at Applebee's.

Motion made by Ald. Dorff; seconded by Ald. Galvin to close the floor.

Motion made by Ald. Dorff to approve the appeal by Jillian Stitamn to the denial of her Operator License application, contingent on a receiving a letter from her employer.

Ald. Scannell suggested amending the motion and asked that the Committee not require an employer's letter.

Motion made by Ald. Dorff; seconded by Ald. Galvin to approve an appeal by Jillian Stitman to the denial of her Operator License application. There were no objections and the motion carried.

The Committee returned to Agenda Item #9.

Motion made by Ald. Dorff; seconded by Ald. Galvin to open the floor.

Brenda Staudenmaier: 423 S. Van Buren St.
Staudenmaier spoke to the Committee regarding an update on her petition to the EPA requesting fluoride to be removed in the water on a national level.

Staudenmaier said the EPA denied their petition. She said the EPA was not ready to let go of the outdated assumptions on fluoride.

The petition presented evidence demonstrating that fluoride is a neurotoxin being ingested by children and vulnerable populations. They also presented that fluoride has little benefit when swallowed. Any risks from exposing fluoride chemicals are unnecessary.

She believes that an impartial judge will agree. She will challenge the EPA's denial in court and is confident on the merits of the petition.

Staudenmaier said fluoride is a neurotoxin. The question therefore, is not if fluoride damages the brain, but at what level does it do the damage.

Staudenmaier said the 2006 National Research Council said fluoride can lead to renal, endocrine and gastrointestinal disease. She also noted that it is immoral to be mass medicated and is contradictory to modern principals of pharmacology. Ald. Zima clarified that the communities are allowed to make a decision on fluoride and the petition was based on a national level.

Staudenmaier asked Quirk about the NSF regulations and Green Bay's compliance of water quality.

Quirk discussed the numeric formula used to come to the value. Quirk said Green Bay's water does meet the standards of NSF and AWWA Standard B703.

David Dunlop at 410 N. Ashland:

He said a number of municipalities have abandoned the standard of fluoride. He asked if we are following the leaders or behind the curve. The public policy should be looked at and the scientific evidence be reviewed. He asked the Committee to look at those who took fluoride out of the water and look at their reasoning. He also asked the Committee to review if the municipalities have been cited.

Michael Finney, 2428 Bay Settlement Road, spoke against fluoride in our water. He mentioned the 2006 study that showed there was a concern on fluoride. Fluoride is an endocrine destructor, meaning it is having an effect.

Ald. Dorff asked more for information on the 2006 statements from the National Academy.

Finney said it was a 507 page study done by 12 leading experts in the National Academy of Science that is unbiased. The study stated fluoride has the ability to effect function of the brain and the body by direct and indirect means. He said fluoride is an endocrine destructor. Fluoride can also cause decreased thyroid function and kidney disease.

Keith Decker, 2421 Mountain Trail, spoke against fluoride in Green Bay's water.

He handed an e-mail to the committee regarding the studies to show the cause of concern of fluoride. He believes a mass medication of water is fundamentally wrong.

David VanderLeest 146 Alpine Dr.

He said there is a difference in putting fluoride on topical versus drinking it. He suggested putting the decision to a referendum to place the decision in the hands of the community.

Nicole La Forge at 4481 Nicolet Drive spoke against fluoride in our water and mass medication. She noted eight different cities in Wisconsin have abandoned fluoride in the water.

Robbyn Kuester, Fluoridation Program Coordinator WI Department of Public Health spoke in favor of fluoride in our water. She said fluoridation of water is safe and effective.

Kuester said expert panels have considered the available evidence and found a lifetime of drinking fluoridated water at the optimal level results in no adverse condition for any groups of individuals or individuals.

She addressed the denial of Staudenmaier's petition and read from the EPA's 40-page response as to why it was denied.

She said 90 percent of the population in Wisconsin has access to fluoridated water. The decision is a decision made on the local level. Those who have stopped using fluoride are typically smaller communities with outdated infrastructure and the cost to update the infrastructure and cost of fluoride is too much.

She also noted fluoridation water programs are growing and not decreasing.

Ald. Zima asked if Kuester could elaborate about communities that don't have fluoridation in their water and the dangers these communities have subjected themselves to.

Kuester said there is a health and economic impact.

Mary Rosner, a resident at 1868 Dousman St., spoke in favor of fluoride in our water.

Dr. Rick Vander Heyden, a dentist in Allouez, spoke in against of fluoride in our water. He asked himself as a dentist if he should do the fluoride treatments or not. He found the little bit people could benefit from was not worth the risk. The risk to reward was just not there.

Ald. Zima asked if the amount of fluoride in our water is doing any good or if it is the brushing and flossing and care.

He said it is the proper teeth care that helps and not the water.

Dr. Mark Moss, the State Dental Director, spoke in favor of fluoride in our water.

He said it is good to be skeptical, however, look at the best evidence out there.

Ald. Galvin asked Moss's opinion on the studies presented by those against fluoride in water.

Dr. Moss stated that it is important to look at the different variables like biasness, measurement, selection and confounding, and noted there is no perfect study.

Ald. Zima asked Moss to elaborate on the study of the fluoride and osteosarcoma.

Dr. Moss mentioned there was an animal study that raised a lot of concerns. The study was based on just male rats. There were questions if the study on if it was a fluke or solid evidence. The research community found it to no be evidential.

Ald. Zima asked if they need fluoride all the time or if it could be something that just once a week would be fine. He expressed concerns of drinking it.

Dr. Moss said that in his mind it is safe.

Jenna Linden, Clinical Director of Oral Health Partnership, spoke in favor of fluoride in our water.

She said fluoride can help tooth decay by 25 percent. One way of reaching children and the population is by fluoridating water. We cannot guarantee compliance and fluoridation in water can help.

Chris Le Roy, 2760 Humboldt Rd., spoke against fluoride in our water. He brought a tube of common toothpaste and read the warning label. He said he does not use the toothpaste with the fluoride anymore. He mentioned he buys bottled water, but does like to take a bath nightly. Fluoride is going into the body through our skin. He does not like it in the water supply.

Dave Thompson, a practicing dentist in Green Bay, spoke in favor of fluoride in our water. He said it is the most positive and impactful public health measure that has taken on this country in the last 50 years.

Ald. Scannell asked if anyone would like to speak on the issue.

Keith Decker-

Decker spoke in regards to Moss's information. He said that there are large professional prestigious groups that are against fluoride as well. There are authorities before and against and asked the committee to see the reasonable cause of concern.

Staudenmaier asked if it is worth it to expose your whole body to a neurotoxic substance to save a ½ or one cavity.

Tom Nockerts, a Green Bay Dentist, spoke in favor of fluoride in our water. Fluoride is geared towards the segment of the population that does not get to the dentist.

Ald. Wery spoke to the Committee and asked the information be passed to the rest of the Council to help make an informed decision.

Vander Leest of Alpine Drive spoke before the committee. He asked if there are any studies in the advances of dental health. He recommended having a referendum to let citizens decide.

Motion made by Ald. Dorff; seconded by Ald. Galvin to close the floor. Motion carried.

Motion made by Ald. Galvin; seconded by Ald. Dorff to take a recess. Motion carried.

Motion by Ald. Galvin; seconded by Ald. Dorff to return to regular order. Motion carried.

Ald. Scannell said he did not support taking fluoride out of Green Bay's water at this time. He said there are a lot of studies available, but the most prominent scientific establishments support fluoridating water.

He noted science is a community and not an individual exercise. As more research is presented his decision could change at a later time. At this time, he felt it is the wrong move to remove fluoride.

Ald. Scannell mentioned that chlorine is added to our water to prevent cholera and typhoid, which is for the greater good. He noted it is a balancing act between respecting individual rights and helping the community. Until there are other options, it is in the benefit of the community to keep fluoride in the water.

Ald. Zima said there are an increasing number of professionals questioning the established view that fluoride is good. He said he took a community member's challenge of watching at least five minutes of a video. He ended up listening to the whole video. He felt there are questions that are credible on the opposite side of fluoridation.

He said previously, he did drink the tap water because it comes from Lake Michigan and thought it was probably good for him. He didn't feel it did any serious harm that he knew of, but can't explain all of his aches and pains.

He hoped for an ongoing discussion about fluoride. He noted all the professionals are not on one side, but rather both.

Ald. Zima made a motion to review again in a month and have a debate and acknowledge if there is something to this or not. There was no second. Motion failed.

Ald. Dorff said the full Council will want to weigh in on the decision to remove fluoride. Council is where the decision is to be made and asked people to attend the Council meeting to express their opinion.

Ald. Dorff didn't like the idea of having a referendum to make the decision. She said the community would not have the advantage of listening to expert witnesses. She felt the people with the most money would have the most commercials and advantage.

Ald. Dorff didn't like the idea that keeping fluoride in our water is a conspiracy theory. She watched one of the videos and found there were some leaps in their conclusions.

Ald. Dorff quoted Dr. Moss stating "It's good to be skeptical." She said more research needs to be done and a risk/benefit analysis be reviewed. Ald. Dorff suggested to keep doing what you are doing, but never stop questioning.

Ald. Dorff noted how tobacco was once thought to be helpful. Her mother was smoking while pregnant and that was considered okay. She said obviously, society has come a long way.

Ald. Dorff is not convinced she wanted to move away from the resolution currently in place. However, she is willing to listen and continue studying.

Ald. Galvin said the other three alders expressed how he feels. He noted there are passionate people on both sides. Ald. Galvin referenced issues with windfarms in Brown County. He noted the County has struggled on what to do with that.

Ald. Galvin said he was not in support of eliminating fluoride in our drinking water at this time. It appears to be a benefit throughout the community. He said he saw the effect of tooth decay in his job. He said he can't support removing it, but the City needs to keep doing research and moving forward so we are doing what's best for the citizens.

Ald. Zima suggested an ongoing discussion for the next couple of years, like the County has done with windmills.

Motion made by Ald. Galvin; seconded by Ald. Dorff to receive and place on file a request by Brenda Staudenmaier to rescind the resolution authorizing fluoride chemicals in public drinking water. Alders Galvin, Dorff and Scannell voted yes to receive and place on file. Ald. Zima voted no.

Motion to adjourn made by Ald. Dorff; seconded by Ald. Galvin. Motion carried.

GENERAL ORDINANCE NO. 25-20

AN ORDINANCE CREATING CHAPTER 50, GREEN BAY MUNICIPAL CODE, RELATING TO EQUAL RIGHTS

THE COMMON COUNCIL OF THE CITY OF GREEN BAY DOES ORDAIN AS FOLLOWS:

SECTION 1. Chapter 50, Green Bay Municipal Code, is hereby created to read:

50.01 Findings; Declaration of Policy.

- (1) A vibrant, livable, successful, and productive city is made possible by the talents, contributions, and well-being of its diverse residents. It is the policy of the City that the equal rights of all those who live and work in the City are ensured, and that equal rights and equal opportunities within the context of the larger commercial and social fabric of the Green Bay community are promoted.
- (2) The practice of providing equal opportunities to persons without regard to actual or perceived sex, race, religion, creed, color, national origin, ancestry, age, disability, lawful source of income, receipt of rental assistance, marital status, familial status, sexual orientation, gender identity, gender expression, gender non-conformity, transgender status, past or present military service, or status as a victim of domestic abuse, sexual assault, or stalking is a desirable goal of the City and a matter of legitimate concern to its government. Discrimination against any City resident endangers the rights and privileges of all residents. The denial of equal opportunity intensifies group conflict, undermines the foundations of democratic society, and adversely affects the general welfare of the community. Denial of equal opportunity in housing forces individuals and families who are discriminated against to live in housing that falls below reasonably acceptable standards. Denial of equal opportunity in employment deprives the community of the fullest productive capacity of those of its members so discriminated against and denies to them the sufficiency of earnings necessary for maintaining the standards of living consistent with their abilities and talents.
- (3) The provision of adequate safeguards against discrimination is a proper and necessary function of City government. To protect the health, safety, and general welfare of all inhabitants of and all persons employed within the City, it is declared to be the public policy of the City to foster, protect, and enforce the right to equal opportunity without regard to sex, race, religion, creed, color, national origin, ancestry, age, disability, lawful source of income, receipt of rental assistance, marital status, familial status, sexual orientation, gender identity, gender expression, gender non-conformity, transgender status, past or present military service, status as a victim of domestic abuse, sexual assault,

or stalking, or an individual's affiliation or perceived affiliation with any of these categories. To fully effectuate this policy of promoting nondiscrimination, the City shall endeavor to eliminate all discrimination that may occur in the City.

- (4) Where applicable, this chapter shall be interpreted and applied consistently with the provisions of Title VII of the Civil Rights Act of 1964, as amended; Title VIII of the Civil Rights Act of 1968; 42 U.S.C. § 2000a, et seq.; 42 U.S.C. §§ 3601, et seq.; 24 C.F.R. §§ 100, et seq.; 29 C.F.R. 1600, et seq.; §§ 66.1011, 106.50, 106.52, and 111.31-111.395, Wis. Stats.; and any successor provisions of state and federal law.

50.02 Purpose. Each sector of society engaged in the life of the City has a role in promoting equal rights, equity, and a social fabric free of discrimination. City government is uniquely positioned to assume a primary leadership role in these efforts. To achieve this leadership objective, each department, agency, and unit of City government shall be accountable for promoting social and economic equity for all residents of the City, and structuring its work so that the outcomes are directed toward social and economic equity for all residents.

50.03 Definitions. In this chapter:

- (1) *Ancestry* means the country, nation, tribe, or other identifiable group from which one descends.
- (2) *Commission* means the Equal Rights Commission.
- (3) *Covered multifamily dwelling* shall have the same meaning as its definition in 24 C.F.R. § 100.201, as amended from time to time.
- (4) *Disability* means, with respect to a person, any of the following:
 - (a) i. A physical or mental impairment which substantially limits one or more of the person's major life activities.
 - ii. A record of having such an impairment.
 - iii. Being perceived as having such an impairment.
 - (b) Disability does not include current, illegal use of or addiction to a controlled substance.
- (5) *Familial status* means one or more individuals, who have not attained the age of 18 years, being domiciled with a parent or another person having legal custody of such individuals; or the designee of the parent or other person having such custody, with the written permission of the parent or other person. For purposes of this chapter, "familial status" shall include any person who is pregnant or is in the process of securing legal custody of any individual who has not attained the age of 18 years.

- (6) *Gender expression* means a person's external manifestations of gender, which may be expressed through name, pronouns, clothing, haircut, behavior, voice, body characteristics, or other means. A person's gender expression may be the same or different from that associated with the person's assigned sex at birth.
- (7) *Gender identity* means a person's internal sense of their gender. A person's gender identity may be the same as or different from their assigned sex at birth.
- (8) *Gender non-conformity* broadly describes individuals who do not conform to traditional expectations of their assigned sex at birth and/or whose gender expression does not fit neatly into a conventional gender category.
- (9) *Housing* means any building, structure, or part thereof which is used or occupied, or is intended, arranged, or designed to be used or occupied as a residence, home, or place of habitation of one or more human beings, including a mobile home as defined in § 66.0435, Wis. Stats., and any land or part thereof which is offered for sale, lease, or use as a site for a building, structure, or part thereof intended or designed to be used or occupied as a residence, home, or place of habitation of one or more human beings, including a mobile home park as defined in § 66.0435, Wis. Stats.
- (10) *Lawful source of income* means income that is legally derived and that is subject to reasonable and good-faith efforts to verify the lawfulness of its derivation, and includes moneys received from public assistance, pension, and supplementary security income.
- (11) *Marital status* means the status of being married, separated, divorced, widowed, or single.
- (12) *Owner* means any person having the right of ownership or possession or the right of transfer, sale, rental, or lease of any housing, or the agent of any such person.
- (13) *Person* means one or more individuals, labor organizations, employment agencies, corporations, partnerships, associations, cooperatives, legal representatives, mutual companies, joint-stock companies, trusts, unincorporated organizations, trustees, trustees in bankruptcy or receivers or other fiduciaries, and the agent or agents of any of the foregoing; but, because of actual, potential, or perceived conflicts of interest, shall not include the City of Green Bay, the Green Bay Housing Authority, the Redevelopment Authority of the City of Green Bay, any department of the City, or any other municipal, state, or federal governmental body or any agent, officer, or employee acting in the course of such employment.

- (14) *Protected Person* means any individual intended to be protected from violations of prohibited discrimination under this chapter. This includes protections afforded based on an individual's actual or perceived sex, race, religion, creed, color, national origin, ancestry, age, disability, lawful source of income, receipt of rental assistance, marital status, familial status, sexual orientation, gender identity, gender expression, gender non-conformity, transgender status, past or present military service, status as a victim of domestic abuse, sexual assault, or stalking, or an individual's affiliation or perceived affiliation with any of these categories.
- (15) *Public Place of Accommodation or Amusement* includes those accommodations, facilities, and services that a person holds out to be open to the common and general use, participation, and enjoyment of the public for any purpose. The term "Public Place of Accommodation or Amusement" shall be interpreted broadly to include, but not be limited to, places of business or recreation, hotels, motels, resorts, restaurants, taverns, barbers, cosmetologists, aestheticians, electrologists, manicuring establishments, nursing homes, clinics, hospitals, cemeteries, and any place where accommodations, amusements, goods, or services are available either free or for consideration, except where such a broad interpretation would deny to any person rights guaranteed by the constitutions of Wisconsin and of the United States. This term does not include:
- (a) Any institution or club which by its nature is distinctly private; or
 - (b) Any religious organization, association, or society, or any nonprofit institution or organization controlled by a religious organization, including places of worship; or
 - (c) A place where a bona fide private, nonprofit organization or institution provides accommodations, amusement, goods, or services during an event at which the organization or institution provides the accommodations, amusement, goods, or services to the following individuals only:
 - 1. Members of the organization;
 - 2. Guests named by members of the organization or institution; and/or
 - 3. Guests named by the organization or institution.
- (16) *Receipt of Rental Assistance* means receipt of rental assistance under Title 24, Code of Federal Regulations, Subtitle B, Chapter VII (commonly known as the Section 8 program) or any other rental assistance that is not considered household income.
- (17) *Sexual Orientation* means the type of sexual, romantic, emotional, or spiritual attraction one has the capacity to feel for some others, generally labeled based

on the gender relationship between the person and the people to whom they are attracted.

- (18) *Transgender* broadly refers to individuals whose gender identity and/or expression is different from cultural expectations based on the sex they were assigned at birth. Being transgender does not imply any specific sexual orientation.

50.04 Housing Discrimination Prohibited.

- (1) In this section, prohibited discrimination includes discrimination because of the protected person status of the buyer, renter, or applicant, or any person residing in or intending to reside in a dwelling after it is sold, rented, or made available.
- (2) It shall be an unfair discrimination practice and unlawful and hereby prohibited:
- (a) For any owner to refuse to transfer, sell, or rent, or to refuse to negotiate for the sale, or rental of, or to otherwise make unavailable, deny, or withhold from any person such housing because of the person's status as a protected person.
 - (b) For any owner to discriminate against any person in the terms, conditions, or privileges of the transfer, sale, or rental of any housing, or in the provision of services or facilities in connection therewith, because of the person's status as a protected person. Nothing in this section shall be deemed to prohibit a housing provider from considering a history of disruptive, abusive, or dangerous behavior.
 - (c) For any person to make, print, publish, post, or broadcast, or cause to be made, printed, published, posted, or broadcast any notice, statement, or advertisement with respect to the sale, rental, or financing of a dwelling that expresses any preference, limitation, specifications, or discrimination, or an intention to make such preference, limitation, specification, or discrimination, as to any protected persons.
 - (d) For any owner to falsely represent to any person that any dwelling is not available for inspection, sale, or rental on the basis of a prospective occupant's or tenant's status as a protected person. A person who has received written notice from the Green Bay Police Department that a drug nuisance under § 823.113, Wis. Stats., exists on property for which the person is responsible as owner may take action to eliminate the nuisance, including but not limited to eviction of residents, provided such action is not a subterfuge to evade the provisions of this chapter.

- (e) For any person to induce or attempt to induce any person to sell or rent a dwelling by representations regarding the entry or prospective entry into the neighborhood of protected persons or persons of a particular economic status or by representations to the effect that such present or prospective entry will or may result in any of the following:
1. The lowering of real estate values in the area.
 2. A deterioration in the character of the area.
 3. An increase in criminal or antisocial behavior in the area.
 4. A decline in the quality of the schools or other public service facilities in the area.
- (f) For any person or other entity whose business includes engaging in residential real estate-related transactions to discriminate against any person in making available such a transaction, or in the terms or conditions of such a transaction, because of a person's status as a protected person. As used in this section, the term "residential real estate-related transaction" means any of the following:
1. The lending of money or security, guaranteeing any loan, accepting any mortgage, or in any other manner making available any other funds or resources for the construction, acquisition, purchase, rehabilitation, repair, improvement, or maintenance of any housing or housing accommodation.
 2. The selling, brokering, or appraising of residential real property. Nothing in this section prohibits a person engaged in the business of making or furnishing appraisals of residential real property from taking into consideration factors other than a person's status as a protected person.
- (g) For any owner to make or cause to be made any written or oral inquiry or record concerning the nature of any disability of prospective occupants or tenants of such housing, or persons associated with them, unless such inquiry or record is necessary for compliance with applicable local, state, or federal law.
- (h) For any person to refuse to permit, at the expense of the person with a disability, reasonable modifications of existing premises occupied or to be occupied by such person if such modifications may be necessary to afford such person full enjoyment of the premises, except that, in the case of a rental, an owner may condition permission for such a modification on the renter agreeing to restore the interior of the premises to the condition that existed before the modification, reasonable wear and tear excepted.
- (i) For any person to refuse to make reasonable accommodations in rules, policies, practices, or services, when such accommodations may be

necessary to afford persons with a disability equal opportunity to use and enjoy a dwelling.

(j) *Animals assisting persons with disabilities.*

1. If a protected person with a disability keeps an animal that is specially trained to assist the disabled person, it is discrimination for any person to refuse to sell or rent housing to the protected person, cause the eviction of the person from the housing, require extra compensation from the person as a condition of continued residence in the housing, or engage in the harassment of the person because of their service animal, if all of the following apply:
 - i. Upon request, the protected person shows to the owner credentials issued by a school recognized by the State or an agency thereof as accredited to train animals for individuals with disabilities; and
 - ii. The protected person accepts liability for sanitation with respect to, and damage to the premises caused by, the animal.
2. This subsection does not apply in the case of the rental of owner-occupied housing if the owner or a member of the owner's immediate family occupying the housing possesses and, upon request, presents to the person a certificate signed by a physician which states that the owner or family member is allergic to the type of animal the protected person possesses.

(3) Nothing in this section shall affect any person's decision to share occupancy of a lodging room, apartment, or dwelling unit with another person or persons.

(4) *Information Allowed.*

- (a) Nothing in this section shall be deemed to prohibit an owner from requiring that any person who seeks to buy, rent, or lease any housing supply information concerning the person's prior residence, or familial, marital, financial, and business status.
 - (b) Nothing in this section shall be deemed to prohibit an owner from refusing to sell, rent, or lease any housing to any person on the basis of such person's treatment of any property formerly occupied by such person or on the basis of such person's record in paying rent or other obligations when due, or such person's ability to pay.
- (5) The prohibition in this section against discrimination against a person with protected person status because of the person's age or familial status does not apply to housing for older persons, as defined in § 106.50(1m)(m), Wis. Stats., as amended from time to time.

- (6) It is not a violation of this ordinance to restrict occupancy in a dwelling to persons with disabilities or to provide housing for older persons as defined in § 106.50(1m)(m), Wis. Stats., as amended from time to time.
- (7) It is not a violation of this ordinance to restrict occupancy in a dwelling to protected persons or to provide housing for protected persons as provided under any state or federal program that is specifically designed and operated to assist persons in a protected class, as defined in the state or federal program. For example, it is not a violation of this ordinance to restrict occupancy in a dwelling to veterans, homeless individuals, or survivors of domestic violence.
- (8) It is not a violation of this ordinance for a religious organization, association, or society, or any nonprofit institution or organization operated, supervised, or controlled by or in conjunction with a religious organization, association, or society, from limiting the sale, rental, or occupancy of dwellings which it owns or operates for other than a commercial purpose to persons of the same religion, or from giving preference to such persons.

50.05 Discrimination in Public Places of Accommodation or Amusement Prohibited.

- (1) All persons shall be entitled to the full and equal enjoyment of the goods, services, facilities, privileges, advantages, and accommodations of any public place of accommodation or amusement, as defined in this ordinance, without discrimination upon the basis of a person's status as a protected person.
- (2) It shall be an unfair discrimination practice and unlawful and hereby prohibited:
 - (a) For any person to deny to another, or to charge another a price different from the regular rate charged to others for the full and equal enjoyment of any public place of accommodation or amusement because of the person's status as a protected person.
 - (b) For any person to directly or indirectly publish, circulate, display, mail, or otherwise disseminate any written communication which the communicator knows is to the effect that any of the facilities of any public place of accommodation or amusement will be denied to any person by reason of status as a protected person, or that the patronage of a protected person is unwelcome, objectionable, or unacceptable for any reason.
 - (c) For any person to subject a person, directly or through contractual, licensing, or other arrangements, to a denial of the opportunity to participate in or benefit from the goods, services, facilities, privileges, advantages, or

accommodations of an entity on the basis of the individual's status as a protected person.

(d) For any person to, notwithstanding the existence of separate or different programs or activities provided in accordance with this section, deny an individual the opportunity to participate in programs or activities that are not separate or different on the basis of the individual's status as a protected person.

(3) This section does not prohibit special services, rates, or benefits provided to veterans or to any protected person fifty (50) years of age or older.

50.06 Access by Persons with Disabilities to Public Places of Accommodation or Amusement.

(1) No individual shall be discriminated against on the basis of disability, or because of the known disability of an individual with whom the individual or entity is known to have a relationship or association, in the full and equal enjoyment of the goods, services, facilities, privileges, advantages, or accommodations of any public place of accommodation or amusement by any person who owns, leases (or leases to another), or operates a public place of accommodation or amusement.

(a) *Denial of Participation.* It shall be prohibited discrimination to subject an individual, on the basis of a disability, directly or through contractual, licensing, or other arrangements, to a denial of the opportunity to participate in or benefit from the goods, services, facilities, privileges, advantages, or accommodations of an entity.

(b) *Participation in Unequal Benefit.* It shall be prohibited discrimination to afford an individual, on the basis of a disability, directly or through contractual, licensing, or other arrangements, with the opportunity to participate in or benefit from a good, service, facility, privilege, advantage, or accommodation that is not equal to that afforded to other individuals.

(2) A public place of accommodation or amusement shall make reasonable modifications in policies, practices, and procedures to permit the full and equal enjoyment of the public place of accommodation or amusement by a person with a disability. Those policies, practices, and procedures shall ensure that a person with a disability is not segregated from other patrons of the public place of accommodation or amusement.

(3) This section is not intended to impose a greater duty than the reasonable accommodation requirements of the Americans with Disabilities Act Amendments Act of 2008.

- (4) *Exemptions for Private Clubs and Religious Organizations.* The provisions of this section shall not apply to private clubs or organizations exempted from coverage under Sec. 50.03 above, or to religious organizations or entities controlled by religious organizations, including places of worship, to the extent that requiring compliance would violate state or federal law.

50.07 City Facilities. It shall be an unfair discrimination practice and unlawful and hereby prohibited for any person, public official, employee, agent, agency, authority, board, commission, or committee of the City of Green Bay to deny any person the use of City facilities or otherwise discriminate against any person in the use of City facilities because of such person's status as a protected person.

- (1) This section is not intended to impose a greater duty than the reasonable accommodation requirements of the Americans with Disabilities Act Amendments Act of 2008.

50.08 Employment Discrimination Prohibited.

- (1) It shall be an unfair discrimination practice and unlawful and hereby prohibited:
- (a) For any person or employer to discriminate against any person with respect to the failure or refusal to hire, discharge, compensation, terms, conditions, or privileges of employment, including promotion, on the basis the person's status as a protected person.
 - (b) For any person or employer, individually or in concert with others, to limit, segregate, or classify employees or applicants for employment in any way which would deprive or tend to deprive any person of employment opportunities or which would otherwise adversely affect their status as an employee because of such person's status as a protected person.
 - (c) For any person or employer to fail or refuse to refer for employment, or otherwise to discriminate against any person in a manner that would deprive or limit the person's employment opportunities or otherwise adversely affect their status as an applicant or prospective employee, on the basis of the person's status as a protected person.
 - (d) For any person or employer to refuse to reasonably accommodate an employee's or prospective employee's disability, unless the employer can demonstrate that the accommodation would pose an undue hardship on the employer's program, enterprise, or business.
 - (e) For any person or employer to refuse to reasonably accommodate an employee's or prospective employee's religious observance or practice, unless the person or employer can demonstrate that the accommodation

would pose an undue hardship on the employer's program, enterprise, or business.

- (2) It is the policy of the City of Green Bay to include in all contracts negotiated or renegotiated by a contracting department of the City a provision obligating the contractor not to discriminate against any qualified employee or qualified applicant for employment on the basis of a person's status or perceived status as a protected person, and to require the contractor to include a similar provision in all subcontracts.
- (3) *Sexual Harassment.* No employer, labor organization, or employment agency shall engage in sexual harassment, and employers shall ensure that all of their employees work in an environment free of sexual harassment.
- (4) *Exceptions.* Notwithstanding any other provision of this section, the following are permitted practices which do not violate this section:
 - (a) For any employer to hire and employ employees, for an employment agency to classify or refer for employment any person, for a labor organization to classify its membership or to classify or refer for employment any person, or for an employer or a labor organization to admit or employ any person in those certain instances where religion, sex, age, or national origin is a bona fide occupational qualification reasonably necessary to the normal operation of that particular business or enterprise.
 - (b) For any employer to observe the terms of a bona fide seniority system or any bona fide employee benefit plan such as a retirement, pension, or insurance plan, which is not a subterfuge to evade the purposes of this section, except that no such employee benefit plan shall excuse the failure to hire any person.
 - (c) For an employer to take the behavioral manifestations of an applicant's mental disability into consideration in determining whether the applicant is qualified.
 - (d) For any religious organization, association, or society, or any nonprofit institution or organization operated, supervised, or controlled by or such religious organization, association, or society, to give preference to an applicant or employee who is a member of the same or a similar religious denomination, in hiring or promotion to an instructional or policymaking position, including but not limited to the position of chaplain or counselor.
 - (e) For any employer, labor organization, or employment agency to fail or refuse to hire a person with a disability if the employer, labor organization, or employment agency can show that the person's disability is reasonably

related to their ability to adequately undertake the job-related responsibilities of the employment.

- (f) For an employer to apply different standards of compensation, or different terms, conditions, or privileges of employment, pursuant to a bona fide seniority or merit system, or a system which measures earnings by quantity or quality of production, or to employees who work in different locations, provided that such differences are not the result of an intention to discriminate because of status as protected persons.

50.09 Enforcement and Jurisdiction.

(1) *Complaints.*

- (a) Any person who claims to have been aggrieved or injured under this chapter may file a written complaint with the city clerk alleging a discriminatory practice or violation. The complaint shall be in writing and signed by the complainant. Such complaints shall be filed within 300 days after the alleged violation of this chapter.

- (b) The complaint shall contain the following information:

- i. The complainant's name, address, and telephone number;
- ii. The name and address of the person(s) or entity the complainant alleges discriminated against them or violated this code;
- iii. The names, addresses, and telephone numbers of witnesses, if any;
- iv. The date or dates of the alleged violation or discriminatory practice;
- v. A statement describing in detail the alleged violation or discriminatory practice;
- vi. A short description of any injury suffered;
- vii. Any other facts the complainant believes are important; and
- viii. The original signature of the complainant.

- (2) *Review of Complaint.* The city clerk shall provide a copy of a timely-filed complaint to the city prosecutor for preliminary review for completeness and jurisdictional determination under subsection (4).

- (a) If the city prosecutor determines that the complaint does not satisfy the requirements of subsection (1), the city prosecutor shall return the complaint to the complainant without taking any action, and notify the complainant what information is missing from the complaint.
- (b) If the city prosecutor determines that the City does not have jurisdiction over the complaint, the city prosecutor shall notify the complainant in writing that the City does not have jurisdiction, and shall direct the complainant to the appropriate state or federal agency.

(c) Upon receipt of a verified complaint over which the City has jurisdiction, the city prosecutor shall initiate enforcement proceedings in municipal court.

i. The city attorney shall have the authority to issue subpoenas compelling the attendance of witnesses and production of documents for actions arising under this section. Such subpoenas shall be served according to §§ 885.03 and 885.04, Wis. Stats. Failure to comply with a subpoena issued under this section may result in contempt, as described in § 1.32(8), GBMC.

(3) *Jurisdiction.* The city shall not exercise jurisdiction over any complaint that sets forth or states any facts or allegations that are within the subject matter jurisdiction of any state or federal equal rights agency, including, but not limited to, the U.S. Equal Employment Opportunity Commission (EEOC) or the Equal Rights Division of the Wisconsin Department of Workforce Development (ERD), regardless of whether the complainant has chosen to file with that agency.

(a) The city prosecutor shall take no action on any complaint against the City of Green Bay or any public official, employee, agent, agency, authority, board, commission, or committee thereof. The city prosecutor shall refer the complaint to the ERD, EEOC, the U.S. Department of Housing and Urban Development (HUD), or any other state or federal agency that has jurisdiction over the complaint for appropriate action as provided by law. The complainant shall be informed of all such referrals.

50.10 Forfeiture. Any person violating any of the provisions of this section shall, upon conviction, be subject to a forfeiture of not more than one thousand dollars (\$1,000.00).

50.11 Equal Rights Commission.

(1) *Members.* The Equal Rights Commission shall consist of nine (9) residents of the City, appointed from a diverse and representative cross-section of the community, inclusive of traditionally underrepresented groups, who shall be members only so long as they shall reside in the City. The membership of the Commission shall include one Alder.

(2) *Appointment.* Members of the Commission shall be appointed by the mayor, subject to confirmation by the council. The Alder shall be elected for a term of two (2) years, and all other members of the Commission shall be appointed for a term of three (3) years, except that three (3) members initially appointed shall

be appointed for a term of two (2) years, and two (2) members initially appointed shall be appointed for a term of one (1) year. Each member shall hold office until a successor is appointed and confirmed. A vacancy occurring other than by expiration of the member's term shall be filled by appointment of the mayor and confirmation by the council for the unexpired portion of the term.

- (3) *Officers.* A chair and vice chair shall be elected from the membership of the Commission at the first regular meeting of each calendar year by a majority of the members of the Commission.

(4) *Powers and Duties.*

- (a) The Commission shall meet not less than four (4) times annually for monitoring the employment, contracting, and program activities of the City, and prepare and provide timely reports to the mayor and council on efforts to promote equal rights, equal opportunities, positive community relations, and to eliminate discrimination and inequities in City government and the City.

(b) *Reporting.*

- i. *Departments.* The human resources department, with the cooperation of all departments, shall regularly provide the Commission with information of efforts and activities undertaken across City government to achieve the leadership objectives described in sections 50.01 and 50.02, Green Bay Municipal Code. This information shall from time to time identify programs and activities conducted by the City to promote equal rights and equal opportunity, as well as goals, challenges, and strategies for the future. The human resources department shall provide the Commission with information about activities and accomplishments with respect to diversity and equal employment opportunity in City employment. Upon request of the Commission, other City departments, agencies, and units shall report to the Commission orally, in writing, or both, at the pleasure of the Commission.
- ii. *Mayor and Common Council.* The Commission shall provide a written communication to the mayor and the Common Council, not less than annually, summarizing the activities of the Commission and the progress of the City in meeting the leadership objectives specified in this chapter. This communication shall further include an examination of those conditions in the City at large which contribute to or detract from equal rights and an environment free from discrimination. The communication shall provide recommendations for furthering the purposes and objectives provided in this chapter.

- (c) The Commission may, at its discretion, engage with employers, housing providers, community organizations, and other stakeholders to create positive working relationships focused on providing equal opportunities throughout the City and raising awareness of important equity issues.

50.12 Construction; Severability.

- (1) The provisions of this chapter shall be liberally construed in order to promote the purposes and provisions contained herein.
- (2) The provisions of this chapter are severable, and if any provision, sentence, clause, section, or part hereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity, unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this chapter or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this chapter would have been adopted if such illegal, invalid, unconstitutional, or inapplicable provision, sentence, clause, section, or part hereof had not been included herein, and if the person or circumstance to which the chapter or any part hereof is inapplicable had been specifically exempted herefrom.

SECTION 2. Section 1.67, Green Bay Municipal Code, is hereby created to read:

1.67 Equal Rights Commission. See § 50.11, Green Bay Municipal Code.

SECTION 3. All ordinances, or parts of ordinances, in conflict herewith are hereby repealed.

SECTION 4. Effective Date. This ordinance shall take effect on and after its passage and publication.

GENERAL ORDINANCE NO. 22-20

**AN ORDINANCE
REPEALING AND RECREATING SECTION 6.39,
GREEN BAY MUNICIPAL CODE,
RELATING TO MOBILE FOOD ESTABLISHMENTS**

THE COMMON COUNCIL OF THE CITY OF GREEN BAY DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 6.39, Green Bay Municipal Code, is hereby repealed and recreated to read:

6.39 MOBILE FOOD ESTABLISHMENTS.

(1) DEFINITIONS.

- (a) “Mobile Food Establishment” means a restaurant or retail food establishment where food is served or sold from a movable vehicle, trailer or cart which periodically or continuously changes location and requires a service base to accommodate the unit for servicing, cleaning, inspection and maintenance or except as specified in the Wisconsin Food Code.
- (b) “Mobile” shall mean the state of being in active, but not necessarily continuous movement.
- (c) “Mobile Food Vendor” means the registered owner of a mobile food establishment or the owner’s agent or employee, or any business which sells edible goods from a mobile food establishment within the City of Green Bay.
- (d) “Edible Goods” shall include but are not limited to:
 - 1. Prepackaged and prepared food including, but not limited to, ice cream, hot dogs, desserts, and pizza.
 - 2. On-site prepared food including, but not limited to, shaved ice, sandwiches, and tacos.
- (e) “Sell” shall mean the act of exchanging a good for profit or in return for a donation.
- (f) “Service Base” means an establishment operated under license or permit of an appropriate regulatory authority where food is manufactured, stored, prepared, portioned or packaged, or any combination of these, where such food is intended for consumption at another establishment or place, and where such units are serviced, cleaned, supplied, maintained, and where the equipment, utensils and facilities are serviced, cleaned and sanitized.

- (g) “Vehicle” shall mean any motor vehicle as defined by Wis. Stats. §340.01(35) or trailer as defined by Wis. Stats. §340.01(71). Vehicle shall also include any bicycle or other self-propelled device.
- (h) “Vend” shall mean to sell or to transfer the ownership of an article to another for a price in money.

(2) LICENSE REQUIRED.

- (a) No mobile food vendor and/or mobile food establishment shall vend, sell or dispose of or offer to vend, sell or dispose of goods, wares or merchandise, produce or any other thing at any place whatsoever in the City of Green Bay, without having obtained an approved license from the City Clerk.
- (b) *License.* Every mobile food vendor shall have a license issued by the City Clerk to conduct business in the City of Green Bay. Each mobile food establishment shall be licensed separately. A mobile food establishment license shall expire on June 30 each year.
- (c) *License Fee.* The license to operate a mobile food establishment shall be \$500.00. If an applicant requests a license under this subchapter from an existing City of Green Bay based business that sells food based products, the license fee shall be \$300.00.
- (d) *License Renewal.* Licenses must be renewed annually. To renew a license, each applicant must submit a renewal application, a renewal fee of \$500.00, and any new permitting documentation upon the license renewal. License renewal from an existing City of Green Bay based businesses shall be \$300.00. If the applicant fails to submit the application and renewal fee within thirty (30) calendar days after the expiration of the license, the applicant shall reapply as a new applicant.
- (e) *Transfer of License.* A license issued under this subchapter shall not be transferable from person to person. A license is valid for one vehicle only and shall not be transferrable between vehicles.
- (f) *Surrender of License; Alteration of License; Failure to Display License.* On the expiration of a license issued under this subchapter, the license holder shall surrender the license to the City Clerk. No person shall alter or change in any manner any license issued under the provisions of this subchapter, and such alteration or the failure of the holder of the license to display the license in a conspicuous place on the mobile unit or his or her person or to exhibit the license upon demand of any officer or customer or prospective vendee shall be cause for revocation of such license.

(3) LICENSE APPLICATION PROCESS.

- (a) *Application.* Any person desiring to operate a mobile food establishment shall apply for a license on a form promulgated by the City Clerk and pay the proper license fee

for each mobile food establishment managed by the person. The City Clerk shall forward the application to the police department for review. If the police department approves the application, the City Clerk shall issue the license to the applicant.

(b) Application Denial. An applicant of a mobile food establishment may be denied where:

1. The circumstances of a pending criminal charge against the applicant substantially relate to the licensed activity.
2. The applicant has been convicted of any felony, misdemeanor or other offense, the circumstances of which substantially relate to the circumstances of the particular job or licensed activity.
3. The applicant made a false statement on the application.
4. The applicant is under eighteen (18) years old.
5. The applicant is found to have unpaid civil judgment(s) which relates to the duties and responsibilities of the permitted occupation which shall be determined by the nature and the amount of the judgment, the relationship of the judgment to the purpose of the permit and the extent that the permit would allow someone to engage in further activity that would lead to unsatisfied civil judgments.

(c) Appeal. If the police department denies an application for a license, the applicant may appeal within fifteen (15) days after the City Clerk mails a notice of denial to the applicant. If the applicant files a timely appeal with the Clerk, the Clerk shall schedule an appeal hearing before the Protection & Policy Committee.

(d) Hearing before Committee. The Committee may approve any application placed on its agenda only if the applicant is qualified under this section and may place conditions upon approval. The Common Council shall affirm, reverse or modify the Committee decision.

(e) Issuance. The Clerk shall issue the mobile food establishment license if the applicant has completed the application requirements and has been approved by the police department.

(4) LICENSE SUSPENSION OR REVOCATION. The Common Council may revoke or suspend, for no fewer than ten (10) nor more than ninety (90) days, any license under this subchapter for violation by any vendor or vendor's employee or agent of any provision of this chapter or any state law or City ordinance which renders future vending contrary to the public health, safety or welfare, or for fraud or misrepresentation in solicitation under this chapter.

(5) SANITATION REQUIREMENTS. Each applicant must certify that they have received all necessary County and State permits and provide copies thereof to the Clerk's Office.

(6) CONDUCT OF BUSINESS.

(a) General Regulations

1. A licensee shall not falsely or fraudulently misrepresent the quantity, character or quality of any article offered for sale or offer for sale any unwholesome or tainted edible goods, nor intentionally misrepresent to any prospective customer the purpose of his or her solicitation, the name of the business of his or her principal, if any, the source of supply of the goods, ware or merchandise which he or she sells or offers for sale or the disposition of the proceeds of his or her sales.
2. A licensee shall not use the license provided by the City after expiration or revocation of the license.
3. A licensee shall keep the premises in a clean and sanitary condition and the edible goods offered for sale well covered and protected from dirt, dust and insects. All food vendors shall comply with requirements of state and local authorities.
4. A licensee may vend, sell or dispose of, or offer to sell, vend, or dispose of goods, wares, or merchandise in the City of Green Bay between the hours of 6:00 a.m. and 10:00 p.m. All sales within the portion of the downtown district of Green Bay, as defined and displayed in Exhibit A under this subchapter, shall be allowed between the hours of 6:00 a.m. and 3:00 a.m.
5. All business activity relating to the mobile food establishments in the public right-of-way shall be conducted from the curbside of the vehicle at all times. No sales shall be made from a vehicle except from the curbside of said vehicle, unless otherwise authorized by the owner of private property.

(b) Zoning Restrictions

1. The vendor of the mobile food establishment shall not operate in any area where such operation impedes or inconveniences public use. No vendor shall engage in the licensed business on any public park, playground, school, library or other public premises without prior approval from the property owner.
2. No mobile food establishment or pedestrian desiring to conduct business at the mobile food establishment shall obstruct an adjacent path or lane of travel. A path or lane of travel includes, but is not limited to sidewalks, motor vehicle lanes, bicycle lanes and other designated parking areas.
3. No mobile food vendor shall be located on any private property without written permission from the property owner. A copy of the written permission shall be kept in the mobile food unit at all times. The mobile food vendor shall comply if asked to leave the private property by the property owner or a city official.

4. No mobile food establishment shall conduct business within five hundred (500) feet of Bay Beach Amusement Park or any fair, festival, special event or civic event that is licensed or sanctioned by the City of Green Bay unless the licensee has obtained written permission from the event sponsor.

(8) PENALTIES. A licensee or vendor who violates any provision of this subchapter or any regulation, rule, or order made hereunder shall be subject to a forfeiture of not less than \$1 nor more than \$500.00 for each offense.

SECTION 2. All ordinances, or parts of ordinances, in conflict herewith are hereby repealed.

SECTION 3. Effective date. This ordinance shall take effect on and after its passage and publication.

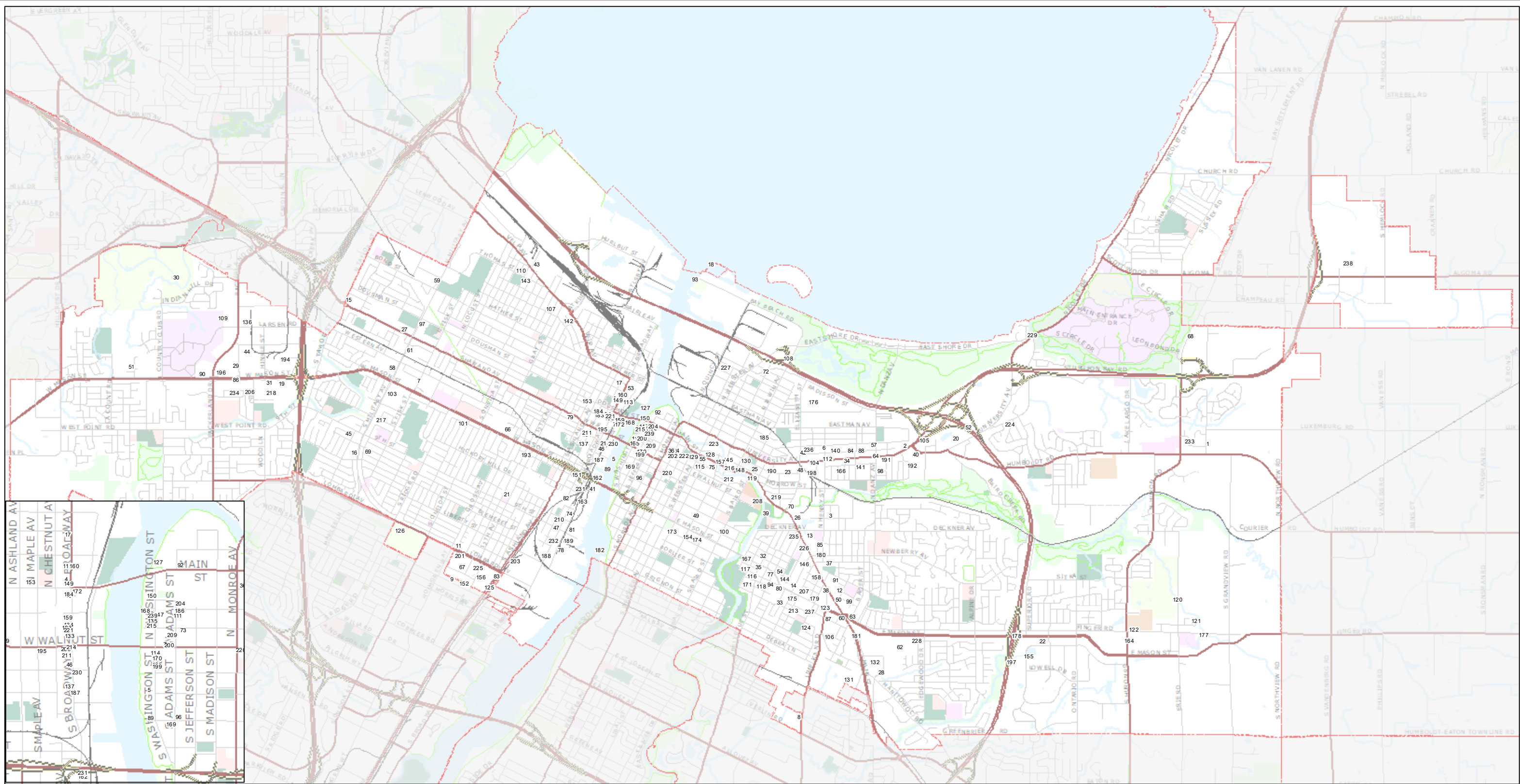

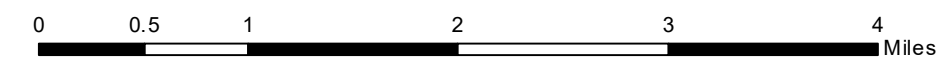
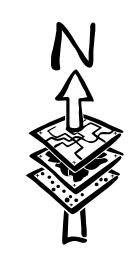
