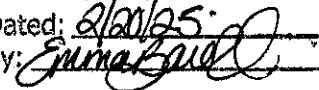

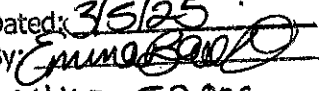

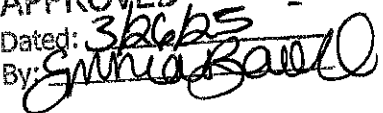

Re: Police Department Sergeant Promotional List

Date: March 31, 2025

The process for the Green Bay Police Department Sergeant promotional list is complete. Attached is an alphabetical list of candidates who successfully completed the process.

Four out of six candidates successfully completed the three steps of the process. The promotional process was comprised of a written test (pass/fail), an assessment center (weighted at 80%) and a peer review (weighted at 20%). The assessment center included citizen complaint, personnel situation and incident management exercises. Candidates must have received a minimum score of 70% in each step of the process to be considered for promotion. Seniority points were added to the candidates' final scores by awarding one point for every three years of service.
