Upon approval, the original retail alcohol beverage license must be brought to the Clerk's Office to have the temporary expanded licensed premises description added to the retail license as an addendum. Any licensee that wishes to extend its premises onto adjacent private property shall provide written authorization from the neighboring property owner. Any licensee that wishes to extend its premises onto City property must provide a certificate of insurance including liquor liability and a separate additional insured endorsement naming the City of Green Bay before any approval of this application can be granted. Any licensee that wishes to extend its premises onto City right-of-way must submit a revocable occupancy permit from the Department of Public Works, issued pursuant to Green Bay Municipal Code section 9.27, along with its application.



To Whom it May Concern:

Richard Craniums would like a temporary expansion of our licensed premise, licensing our back parking lot to provide an outdoor patio for our customers, similar to what we have done the previous four years.

We would like to have the following dates for the 2024-2025 licensing year:

- Tuesdays, May 26<sup>th</sup> to June 30<sup>th</sup> (6 days)
- Wednesdays, May 27<sup>th</sup> to June 24<sup>th</sup> (5 days)
- Sat/Sun from May 23-24<sup>th</sup> to June 27-28<sup>th</sup> (12 days)
- TOTAL: 23 days

(This is in conjunction with the 57 days already utilized, resulting in a total of 80 days in the licensing year)

We would like to have the following dates for the 2025-2026 licensing year:

- Tuesdays, July 7<sup>th</sup> to August 4<sup>th</sup> (5 days)
- Wednesdays, July 8<sup>th</sup> to July 29<sup>th</sup> (4 days)
- Sat/Sun, July 4-5<sup>th</sup> to August 1-2<sup>nd</sup> (10 days)
- Fri/Sat/Sun, August 7-9<sup>th</sup> to November 6-8<sup>th</sup> (42 days)

- TOTAL: 61 days

Attached is a map, showing description of the area to be included in the temporary expansion. It will be fenced in, with access only from entry from the back parking lot, as we have done every previous year.

The location is an unused portion of our lot, directly behind the building, designed to include an outdoor patio.

Tables and patio tables will create physical distancing.

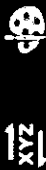
Signage, staff awareness, and a camera system visible to all staff and customers will monitor and secure the area boundaries. We have never had a problem with this strategy, and work well with our customers and law enforcement to provide a safe environment.

The decibel level for the outdoor patio will not exceed 80db past 10pm, which is the standard for the Green Bay Police Department to enforce. Therefore, no special permit will be required. If an event is considered to exceed that amount, we will seek out a special permit for that event.

Our outdoor space will be used primarily for cornhole league on Tuesdays and Wednesdays, and a place on the weekends for customers to relax outside when weather permits. Thank you for your continued help!

# Liquor Licensing

City of Green Bay

# Liquor License Types

- “Class A” Liquor \$425
- Class “A” Beer \$425
  - Gas Stations, Liquor/Grocery Stores
    - *Think of places where alcohol is consumed **A**WAY from establishment*
- “Class B” Liquor \$475
  - there is a quota on these of 172 (determined by state by size of municipality)
- “Class B” Reserve Liquor \$10,000 *one-time issuance fee*
  - also have a quota of 32 (determined by state by size of municipality)
- Class “B” Beer \$75
  - Bars, Restaurants
- “Class C” Liquor License (Wine)\$100

# **Class B Limitations** [125.32\(3m\)](#)

- No other business may be conducted on premises operating under a Class “B” license or permit. These restrictions do not apply to any of the following:
- Hotel
  - Restaurant--whether or not it is a part of or located in any mercantile establishment
  - Combination grocery store and tavern
  - Combination sporting goods store and tavern in towns, villages and 4<sup>th</sup> class cities
  - Combination novelty store and tavern
  - Bowling center or recreation premises
  - Club, society or lodge that has been in existence for 6 months or more prior to the date of filing application for the Class “B” license or permit
  - Movie theater
  - Painting studio
  - Axe throwing facility (*Effective May 1, 2024*)

# Liquor License Premises Description

- Premises Description is an area printed on the license to describe (as stated on the AB-200 form)
  - “the building or buildings where alcohol beverages are produced, sold, stored, or consumed, and related records are kept. Describe all rooms within the building, including living quarters. Authorized alcohol beverage activities and storage of records may occur only on the premises described in this application.”
- Important to review prior to granting as once granted, it may not be taken away.

# Liquor License Quota

- The City of Green Bay may issue up to **172 “available” liquor licenses**.
  - A licensee who holds an “available” liquor license may conditionally surrender the license to another legal entity.
- Failure to file renewal paperwork by June 30<sup>th</sup> will result in the loss of their liquor license.
  - The license will be placed into the pool of available liquor licenses at the first Council meeting after June 30<sup>th</sup>.
- The City of Green Bay may issue up to **32 “reserve” liquor licenses**. *(A municipality may get additional reserve licenses based on population growth.)*
  - A “reserve” liquor license is a one-time \$10,000 issuance fee *(plus the license fee prorated)* to obtain a reserve license

# Liquor License Limits-Location

- No “Class A” or “Class B” license or permit may be issued for premises where the main entrance is less than 300 feet from the main entrance of a public or parochial school, tribal school, as defined in s. [115.001 \(15m\)](#), hospital, or church.
- The prohibition does not apply to any of the following:
  - Premises covered by a license or permit on or before June 30, 1947.
  - Premises covered by a license or permit prior to the occupation of real property within 300 feet thereof by any school, hospital or church building.
  - A restaurant located within 300 feet of a church or school.
  - This applies only to restaurants where the sale of alcohol accounts for less than 50% of gross receipts.
- The City of Green Bay has the Fort Howard Moratorium, which limits the “Class B” liquor licenses issued in the area west of Broadway.
  - An applicant must be a restaurant with 50 percent of gross sales from food.
  - This was set by Charter ordinance and would need a referendum to remove.
  - A person may find if their location is in the Fort Howard Moratorium by going to open data at [greenbaywi.gov](http://greenbaywi.gov)

# Liquor License Premises

## Description-Outdoor Areas

- A licensee may apply to amend its licensed premises to include a patio, given it meets the following requirements:
  - Immediately adjacent
    - to the indoor portion of the licensed premises (*can be accessed from the indoor portion of the licensed premises without crossing any unlicensed area*)
  - Barrier
    - Must be enclosed by a permanent fence, structure, or other barrier that clearly delineates the separation from licensed to unlicensed area. The fence, structure, or other barrier must be at least three feet in height and must clearly separate the licensed premises from any non-licensed area
  - Ingress
    - Access to a licensed patio must be through an indoor licensed area. Egress to an unlicensed area without the ability to return is not limited
